Possession of Child Pornography – On April 30, 2025 a Prince William County detective assigned to the Northern Virginia/DC Internet Crimes Against Children Task Force concluded an investigation into the possession of child pornography. In October 2024, the task force detective opened an investigation after receiving information from the National Center for Missing and Exploited Children (NCMEC) that the accused was in possession of child pornography. During the investigation, detectives conducted a search warrant on the suspect's residence, where they collected electronic items containing child pornography. Following the investigation, the accused, identified as Robert Vincent **CALVILLO**, was arrested.
