DAILY INCIDENT REPORT

May 5, 2025

Updates

Shooting Investigation *ADDITIONAL INCIDENT – On May 2 at 10:28PM, officers responded to the Woodbridge Station Apartments located in the 1500 block of Ranger Loop in Woodbridge (22191) to investigate a shooting. The investigation revealed a man, later identified as the accused, was handling a firearm when a round was discharged. The round entered the apartment below through the ceiling before lodging into the kitchen floor of the apartment. The accused left the apartment prior to police arriving at the scene. No injuries or additional property damage were reported. Following the investigation, officers obtained arrest warrants for the accused identified as Taylohn Jashaud **ANDREWS**. Officers also determined **ANDREWS** has additional active arrest



warrants for a shooting incident that was reported to have occurred in Woodbridge on November 15, 2024. Attempts to locate the accused have been unsuccessful.

Described as a black male, approximately 6'0", 190lbs., with black cornrows, and brown eyes Previously wanted for <u>aggravated malicious wounding</u> and <u>use of a firearm in commission of a felony</u>

Additional warrants for **shooting into a residential dwelling** and **reckless handling of a firearm**

Aggravated Malicious Wounding [Previously Released] – Detectives are seeking the suspect sought in the shooting that was reported to have occurred at the Summerhouse II Condos located in the 1000 block of Gardenview Lp in Woodbridge (22191) on November 15. Detectives identified and obtained arrest warrants for the suspect, identified as Taylohn Jashaud **ANDREWS**. Attempts to locate the accused were unsuccessful.

Shooting Investigation [Previously Released] – On November 15 at 1:39AM, officers responded to the Summerhouse II Condos located in the 1000 block of Gardenview Lp in Woodbridge (22191) to investigate a shooting. The investigation revealed an 18-year-old man was shot in the lower body and found by responding officers next to a vehicle in the parking lot. The man was treated at an area hospital where the injury was determined to be non-life threatening. The altercation is believed to have occurred in a nearby residence where a shell casing and marijuana were located. The man was not forthcoming with investigators as to what led up to the shooting or the other parties involved.

Commercial Burglaries *ARRESTS - On May 2, detectives concluded the investigations into several burglaries that were reported to have occurred in the Woodbridge (22192) area of Prince William County between March 12 and April 20. During the investigation, detectives identified the male suspect involved in seven commercial burglaries as the same suspect sought in the March 13 burglary at Jersey Mikes. Detectives also identified and obtained arrest warrants for the female suspect involved in two of the burglaries at Pizza Hut and Chili on Top located in the Dillingham Square shopping center. Between April 25 and May 2, following the investigation, the suspects identified as Saniyah Ayan Quash **WESLEY** and Tyjaun Cattrell **SMITH**, were arrested.

Commercial Burglaries [Previously Released] – On April 10 at 3:16AM, officers were in the area of the Dillingham Square shopping center located in the 12500 block of Dillingham Sq in Woodbridge (22192) when damage was located to the front door of Hangry Joes. The investigation revealed entry was attempted through the front door, which was found damaged. While checking additional businesses in the area, Dairy Queen and Dollar Tree were found with shattered front glass doors. Officers determined entry had been made into those businesses. A cash register containing an undisclosed amount of money was reported missing from Dairy Queen. No property was reported missing from Hangry Joes and Dollar Tree.

Commercial Burglaries [Previously Released] – On April 7 at 1:56AM, officers responded to the Dillingham Square shopping center located in the 12500 block of Dillingham Sq in Woodbridge (22192) to investigate a burglary. The investigation revealed two businesses, Pizza Hut and Chili On Top, were found with shattered front glass doors. No property was immediately reported missing. Officers and a police K-9 searched the area for the parties involved who were not located. Another burglary in the same shopping center was reported on April 4 at approximately 2:39AM. The investigation revealed a suspect had entered Concept Nails through the front glass door which had been shattered. A cash register was reported missing. It is unknown if the same suspect(s) were involved in the burglaries.

Commercial Burglary [Previously Released] – On April 20 at 5:28AM, officers responded to Burger King located at 2211 Tacketts Mill Dr. in Woodbridge (22192) to investigate a burglary. The investigation revealed sometime between 1:30AM and 4:54AM, forced entry was made into the business through the drive-thru window. No property was reported missing.

Commercial Burglary [Previously Released] – On March 13 at 1:38PM, officers responded to investigate a burglary that was reported to have occurred at Jersey Mikes located at 3282 Old Bridge Rd. in Woodbridge (22192) on March 12 at approximately 10:15PM. The investigation revealed the accused entered the business through an unsecured rear door and took money from the cash register before leaving. Following the investigation, officers obtained arrest warrants for the accused, identified as Tyjaun Cattrell **SMITH**. Attempts to locate the accused have been unsuccessful.

Incidents

Death Investigation – On May 2 at 4:19PM, officers responded to Andrew Leitch Park located at 5301 Dale Blvd. in Woodbridge (22193) to investigate a death. The investigation revealed emergency services were contacted when a passerby located a 23-year-old woman unconscious while on a walking trail. The woman was pronounced deceased on the scene. Preliminarily, there were no signs of foul play. The body was transported to the Medical Examiner's Office for an autopsy to determine the cause and manner of death. At this time, there is no threat to the community concerning the death. More information will be released as necessary.

Armed Robbery – On May 2 at 7:25PM, officers responded to the 14900 block of Diamond View Way in Woodbridge (22191) to investigate a robbery. The investigation revealed the victim, a 55-year-old man, returned to his parked vehicle and located two unknown men inside the vehicle brandishing firearms. The suspects demanded the victim's money and that he drive them to a business in Alexandria. During the encounter, the suspects physically struck the victim with firearms while he was driving. The parties separated while in Alexandria and the victim left the area before contacting the police. No injuries were reported.

Aggravated Assault – On May 4 at 10:49PM, officers initially responded to a local hospital to investigate an assault that was reported to have occurred earlier that evening. The investigation revealed a 36-year-old man was walking in the Woodbridge (22193) area when he was approached from behind and at some point was struck in the head. The man contacted a family member who arranged for transportation to an area hospital. The man refused to cooperate further with the investigation and was treated for injuries determined to be non-life threatening. No additional injuries or property damage were reported.

Armed Robbery – On May 4 at 8:08PM, officers responded to the 3100 block of Antrim Cl. in Dumfries (22026) to investigate a robbery. The investigation revealed the victim, an 18-year-old man, arranged to sell shoes to a known individual via Instagram. Before the sale was completed, the suspect grabbed the shoes and ran from the area. The victim initially followed the suspect, and after a short distance, the victim was approached by two masked individuals brandishing firearms. The victim left the area and contacted police. No injuries were reported. The investigation continues.

May 5, 2025

Arrests

Murder Investigation – On April 16 at 4:29PM, officers responded to the Red Roof Inn located at 17113 Dumfries Rd. in Dumfries (22026) to investigate a death. Upon arriving, officers were informed by fire and rescue personnel that the victim, a 2-year-old girl, was dead. The preliminary investigation revealed there were no immediate signs of trauma or medical concerns. The child was in the care of her parents, later identified as the accused, leading up to the death. Also inside the hotel room at the time was a second child, under the age of 6, who was determined to be unharmed and was released to the custody of known parties. An unsecured firearm was also located inside the hotel room. The body was transported to the Medical Examiner's Office for an autopsy to determine the cause of death. On April 29, detectives received the toxicology exam results, which indicated the child had fentanyl in her heart blood. Further investigation revealed that while the mother contacted emergency services, the father removed items from the hotel room before police and emergency services arrived at the hotel. Following the joint investigation with Child Protective Services and after consultation with the Commonwealth Attorney's Office, detectives obtained arrest warrants for the accused, identified as William Nathaniel **FULLER** and Markita Ayanna **WILLIAMS**. On May 1, detectives and members of the U.S. Marshals Fugitive Task Force located both of the accused in the Dumfries area, where they were arrested without incident.

The parties were known to one another. A family member recently found messaging between the two parties and contacted police. When officers attempted to intervene, one of the involved parties, identified as the accused, struck an officer before being detained. The investigation revealed the accused pushed the victim, a 25-year-old female acquaintance, prior to the police arriving on scene. No injuries were reported. Following the investigation, the accused, identified as Leonardo **ESCOBAR**, was arrested.
