# DAILY INCIDENT REPORT

May 6, 2025

## Incidents

**Strong-Arm Robbery** – On April 11 at 1:34PM, officers responded to investigate a robbery that was reported to have occurred at Bath and Body Works located at 10992 Bulloch Dr. in Manassas (20109) on April 10. The investigation revealed three unknown men entered the store and took several items from the shelves. When an employee of the store confronted one of the men, the suspect threatened the employee before all three men left the store. At no point during the encounter was there any physical contact between the employee and the suspects. While investigating the incident, detectives determined that numerous items of a similar style were missing and identified the suspect who threatened the employee. On May 2, following the



investigation, detectives obtained arrest warrants for the suspect, identified as Delontae Laymont **SHAW**. The investigation continues as detectives attempt to identify the other two suspects and locate the **SHAW** suspect.

Delontae Laymont **SHAW**, 34, of the 1300 block of Congress St., SE in Washington, DC Described as a black male, approximately 5'11", 180lbs., with brown hair and eyes Wanted for *robbery*, *larceny with intent to sell*, and *conspiracy to commit a larceny* 

### Suspect Descriptions:

A black male, between 25-35 years old, approximately 6', with a medium build, and braid/dreadlocks held up in a Nike brand hair wrap

Last seen wearing black unzipped "Milano" brand coat with white and red writing on the left breast of the coat and MILANO written in white lettering on the back, dark pants, and white sneakers

A black male, between 18- 25 years old, approximately 5'10", with a thin build, Last seen wearing a black True Religion hooded sweatshirt with white writing, light-colored stonewashed ripped jeans, and black/red sneakers

### Arrests

**Attempted Malicious Wounding (Domestic)** – On May 5 at 5:29PM, officers responded to a residence located in the 3400 block of Melrose Ave. in Triangle (22172) to investigate a domestic. The investigation revealed the victim, 28-year-old man, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim before retrieving a knife. The accused attempted to cut the victim multiple times with the knife and the victim was able to avoid being cut before the parties separated. The victim reported non-life threatening injuries. Following the investigation, the accused, identified as Sumaiyah lamina **NTENDA NYX**, was arrested.

**Commercial Burglary –** On May 6 at 3:25AM, officers responded to the Ross store located at 13957 Richmond Hwy. in Woodbridge (22191) for an alarm activation. The investigation revealed a man, later identified as the accused, smashed the front door to gain entry into the business. When the accused observed officers outside of the store, he walked out of the business where he was detained without incident and found in possession of suspected illegal drugs. No property was reported missing. Following the investigation, the accused, identified as Anthony Lee **HAYES**, was arrested.
