Incidents

Death Investigation – On May 7 at 7:26AM, officers responded to Braemar Park located at 12401 Braemar Pkwy. in Bristow (20136) to investigate a death. The investigation revealed a 76-year-old man was located in the park with an injury believed to be self-inflicted. Fire and rescue personnel responded and pronounced the man dead on the scene. The body was transported to the Medical Examiner's Office for an autopsy and determination of cause of death. At this time, there is no foul play concerning the death. The investigation continues.

Shooting into a Residential Dwelling - On May 7 at 2:29AM, officers responded to a residence located in the 7600 block of Elim Ct. in Manassas (20111) to investigate a shots fired call. The investigation revealed multiple rounds were fired from a dark-colored sedan driving on Elim Ct. which struck the residence. The sedan quickly drove out of the area prior to police arriving on scene. No injuries or additional property damage were reported.

Armed Robbery – On May 7 at 1:02AM, officers responded to Summerhouse II Condominiums located in the 13600 block of Garfield Pl. in Woodbridge (22191) to investigate a robbery. The investigation revealed the victim, a 34-year-old man, was walking in the above area when he was approached from behind by three unknown men. During the encounter, one of the suspects physically struck the victim with a firearm while the other suspects also struck and kicked the victim. The suspects took the victim's bag before leaving the area on foot. The victim was treated at an area hospital for non-life threatening injuries. Officers and a police K-9 searched the area for the suspects, who were not located. There is no suspect description at this time.

Strangulation [Domestic] - On May 6 at 6:15PM, officers responded to the 13000 block of Chinn Park Dr. in Woodbridge (22192) to investigate a domestic dispute. The investigation revealed the victim, a 29-year-old woman and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused assaulted and choked the victim before the parties separated. The accused left the area prior to the police arriving at the parking lot.
