### Updates

**Commercial Burglary \*ARREST** – On May 3, the suspect sought in connection to the burglary that was reported to have occurred at the Exxon located at 17019 Dumfries Rd. in Dumfries (22026) on April 26, was arrested. During the investigation, detectives identified the accused and obtained warrants for his arrest. On May 3, following the investigation, the accused, identified as Alex Gerald **CHIRWA**, was arrested.

**Commercial Burglary [Previously Released]** – On April 26 at 2:58AM, officers responded to the Exxon located at 17019 Dumfries Rd. in Dumfries (22026) to investigate a burglary. The investigation revealed forced entry was made into the business through the front glass door. Video surveillance footage revealed a masked man smashed the front door before entering the business, where he took an undisclosed amount of money before leaving. Officers and a police K-9 searched the area for the suspect, who was not located. The suspect was last seen wearing dark-colored clothing and a face mask.

### Incidents

**Shooting Investigation** – On May 7 at 12:55PM, officers responded to The Oaks Apartments located in the 3900 block of Soundview Cl. in Triangle (22172) to investigate a shots fired call. The investigation revealed for several minutes an unknown man was observed on video footage attempting to gain entry into an apartment and damaged the door of the apartment before walking away without making entry. Prior to police arriving at the apartment complex, a verbal altercation between two men escalated when one of the men fired multiple rounds before both men ran from the area. One of the rounds struck an apartment pillar and a rear sliding glass door. No injuries and no additional property damage were reported. **The incidents do not appear to be random.** The investigation continues.

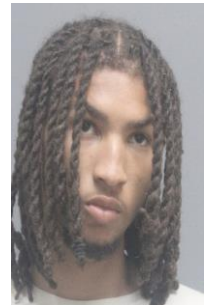
**Indecent Exposure** – On May 7 at 12:08PM, officers responded to Dollar Tree located at 13345 Worth Ave. in Woodbridge (22192) to investigate an indecent exposure. The investigation revealed the victim, a 20-year-old woman, was shopping inside the store when she was approached by an unknown man. After a brief encounter, the suspect exposed himself and began making inappropriate gestures. No physical contact occurred, and the suspect left prior to police arriving in the area.

***Suspect Description:***

A black male, approximately 5'6 ft, with a medium build, shoulder-length dreads and a goatee

## Arrests

**Armed Robbery** – On May 4 at 5:48AM, officers responded to the Motel 6 located at 17133 Dumfries Rd. in Dumfries (22025) to investigate a robbery. The investigation revealed the victim, a 16-year-old male juvenile, left a large gathering inside the above location and was approached by a group of males, including the accused, while in the parking lot. When the victim got into his vehicle, the accused entered the vehicle's passenger side, where he struck the victim multiple times. Shortly after, a second male approached the victim from outside of the vehicle where he assaulted the victim. When the victim attempted to drive out of the parking lot, he struck a parked vehicle, and the accused brandished a knife before taking the victim's shoes. The accused then got out of the vehicle and both of the accused ran from the parking lot and the victim drove out of the area. While investigating the incident, officers identified the two males involved in the robbery and detained them without incident. No injuries were reported. Following the investigation, both of the accused, identified as a **16-year-old male juvenile** and Lamont Curtis **JOHNSON Jr.**, were arrested.

**Assault & Battery on a Law Enforcement Officer [LEO]** – On May 4 at 5:48AM, while officers were investigating the robbery at the Motel 6 located at 17133 Dumfries Rd. in Dumfries (22025) they encountered an intoxicated juvenile. When officers attempted to detain the juvenile, identified as the accused, she actively resisted and kicked an officer before being detained without further incident. No injuries were reported. On May 5, following the investigation, the accused, identified as a **16-year-old female juvenile**, was charged.

**Abduction [Domestic]** – On May 5 at 3:55PM, officers responded to a residence located in the 11900 block of Home Guard Dr. in Woodbridge (22192) to investigate a domestic dispute. The investigation revealed the victims, a 50-year-old woman and a 10-year-old girl, were engaged in a verbal altercation with a family member, identified as the accused, that escalated. During the encounter, the accused assaulted both family members before preventing them from leaving the room. At some point, the accused temporarily separated from the victims before assaulting his mother again. The parties separated prior to police arriving at the residence. Non-life threatening injuries were reported by the victims. Following the investigation, the accused, identified as a **14-year-old male juvenile**, was arrested.

## **Arrests,** *continued*

**Brandishing of a Weapon** – On May 5, officers concluded an investigation into a brandishing that was reported to have occurred at in the area of Dale Blvd. and Kirkdale Rd. in Woodbridge (22193) at approximately 2:00PM on April 26. The investigation revealed the victim, a 63-year-old man, confronted a male juvenile, identified as the accused, over a previous altercation with a family member while in the above area. During the encounter, the accused brandished a knife before the victim left the area. No injuries were reported. Following the investigation, officers sought petitions against the accused. After consultation with Juvenile Court Services, the case resulted in an informal action and will be handled through the juvenile diversion process.
