### Updates

**Fatal Crash Investigation \*ARREST** – On May 8, crash investigators obtained an arrest warrant against the driver of the 2020 Honda Civic involved in the fatal crash that occurred at the intersection of Dale Blvd. and Barksdale St. in Woodbridge (22193) on May 1. The investigation determined the accused was traveling more than 20 miles per hour (MPH) over the posted speed limit of 45MPH at the time of the collision. A 32-year-old woman who was a passenger in the other vehicle involved in the collision was killed. Following the investigation, the driver, identified as Luis Alejandro **ANARIBA**, was arrested.

**Fatal Crash Investigation [Previously Released]** – On May 1 at 6:57PM, officers responded to the intersection of Dale Blvd. and Barksdale St. in Woodbridge (22193) to investigate a crash. The investigation revealed the driver of a 2008 Honda Civic was traveling eastbound on Dale Blvd., and the driver of a 2020 Honda Civic was traveling westbound. With a flashing amber traffic signal, the driver of the 2008 Honda initiated a left turn across the westbound lanes of Dale Blvd. towards Barksdale St., and the vehicles collided. The passenger in the 2008 Honda was extricated from the vehicle and transported to an area hospital, where she later died. The driver of the 2008 Honda was treated at an area hospital for non-life threatening injuries. The driver of the 2020 remained at the scene and was not injured. Speed appears to be a factor for the 2020 Honda. **Crash investigators are asking anyone who may have witnessed this crash to contact police.**

**Strangulation [Domestic] [Previously Released]** – On May 6 at 6:15PM, officers responded to the 13000 block of Chinn Park Dr. in Woodbridge (22192) to investigate a domestic dispute. The investigation revealed the victim, a 29-year-old woman and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused assaulted and choked the victim before the parties separated. The accused left the area prior to the police arriving at the parking lot. Non-life threatening injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Ferdos **OMAR KHALI**. Attempts to locate the accused have been unsuccessful.

**Brandishing of a Firearm \*ARREST** – On May 5, the suspect, identified as Marshad D. **LEDBETTER**, who was sought in connection to the brandishing that was reported to have occurred in the intersection of Opitz Blvd. and Gideon Dr. in Woodbridge (22191) on March 28, was arrested.

**Brandishing of a Firearm [Road Rage Related] [Previously Released]** – On March 28 at 4:08PM, officers responded to the intersection of Opitz Blvd. and Gideon Dr. in Woodbridge (22191) to investigate a brandishing. The investigation revealed the victim, a 36-year-old man, and the driver of another vehicle, identified as the accused, were involved in a road rage incident. While both drivers were stopped at the above intersection, the accused brandished a firearm towards the victim before the parties separated. No shots were fired, and no injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Marshad D. **LEDBETTER**. Attempts to locate the accused have been unsuccessful.

## Incidents

**Death Investigation** – On May 8 at 1:51PM, officers responded to the 10200 block of Golf Academy Dr. in Bristow (20136) to investigate a death. The investigation revealed the deceased, identified as a 32-year-old man, was initially reported missing to police earlier that day by family members. Officers canvassed the above area where the man had previously spent time and located some of his personal belongings. A short time later, the man's body was located and recovered from a nearby pond by Fire & Rescue personnel. Preliminarily, there are no signs of foul play in the man's death. The cause and manner of death is pending by the Medical Examiner's Office.

**Strangulation [Domestic]** – On May 8 at 7:26PM, officers responded to Woodbridge Station Apartments located in the 13600 block of Hornet Way in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed the victim, a 34-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused pushed the victim and grabbed her neck before an 8-year-old male family member attempted to intervene. The accused then pushed the male victim to the ground before the parties eventually separated. The accused left the apartment prior to police arriving on scene. Non-life threatening injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Jose Maria **PEREZ**. Attempts to locate the accused have been unsuccessful.

**Reckless Handling of a Firearm** – On May 8 at 5:55PM, officers responded to the 5000 block of Waterway dr. in Dumfries (22025) to investigate a shots fired call. The investigation revealed an unknown man was observed firing multiple rounds, possibly towards another individual, before leaving the area. Additional males, possibly juveniles, were also seen leaving the area shortly after the shooting occurred. Officers and a police K-9 searched the area for any involved parties who were not located. No injuries or property damage were reported.

## Arrests

**Felony Obstruction of Justice** – On May 8 at 12:10AM, officers initiated a traffic stop in the area of Prince William Pkwy and Trowbridge Dr. in Woodbridge (22192) for a traffic violation. During the stop, the driver of the vehicle, later identified as the accused, disregarded the officer's commands and got out of the vehicle. When officers attempted to detain the accused, he actively resisted and spat on an officer before he was detained. An officer reported a minor injury. Throughout the encounter, the accused made numerous verbal threats towards the officers. Following the investigation, the accused, identified as Geoffrey **DILLARD**, was arrested.

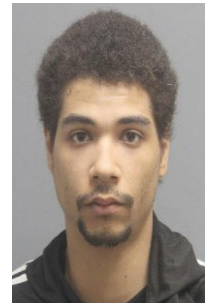

**Stabbing Investigation** – On May 9 at 12:09AM, officers responded to a residence located in the 12500 block of Plymouth Ct. in Woodbridge (22192) to investigate a stabbing. The investigation revealed the victim, a 22-year-old man, approached an acquaintance, identified as the accused, from behind and the accused stabbed the victim. The accused quickly assisted the victim and emergency services were contacted. The victim was treated at an area hospital for non-life threatening injuries. Following the investigation, the accused, identified as Yahaziel **PRETTY**, was arrested.
