Incidents

Fatal Crash Investigation – On May 10 at 10:30PM, a motor vehicle crash was reported in the area of Minnieville Rd. near Prince William Pkwy. in Woodbridge (22193). Members of the Crash Investigation Unit were called to the scene to investigate the crash. The investigation revealed the operator of a 2019 Indian FTR 1200 motorcycle was traveling eastbound on Minnieville Rd. and the driver of a 2019 Kia Soul was traveling westbound. The operator of the Indian motorcycle disregarded a red signal at Prince William Pkwy. as the driver of the Kia Soul initiated a left turn into the path of the motorcycle where the vehicles collided. The rider and motorcycle separated after impact, and the rider was pronounced deceased at the scene. The driver and passenger of the Kia Soul were treated for minor injuries. **Crash investigators are asking anyone who may have witnessed this crash to contact police.** The investigation continues.

Identified:

The deceased operator of the 2019 Indian FTR 1200 motorcycle was identified as Christian Alexis **ZAYAS**, 28, of Woodbridge

The driver of the 2016 Kia Soul was identified as a **61-year-old woman** of Woodbridge

Death Investigation – On May 10 at 6:32PM, officers responded to the area of Morgan Island Way and Links Pond Cl. in Gainesville (20155) to investigate a death. The investigation revealed the deceased, a 23-year-old man, was reported missing to police by family members earlier on May 10. The man reportedly left his home in Gainesville driving his vehicle, a Mercedes ERS on the evening of May 9. While investigating the incident, officers located the unoccupied vehicle in the above area. During a canvass of the wooded area nearby, the man was located with an injury believed to be self-inflicted. Rescue personnel pronounced the man deceased on scene. The body was transported to the Medical Examiner's Office for an autopsy and determination of cause of death. At this time, there is no foul play concerning the death. The investigation continues.

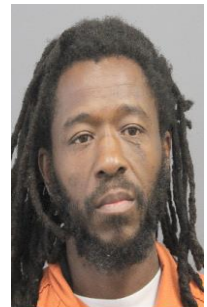

Shooting Investigation – On May 10 at 1:06AM, officers responded to the area of Burr Ln. near Minion St. in Woodbridge (22192) to investigate a shooting. The investigation revealed sometime during the early morning hours, the victim, a 22-year-old man, was reportedly shot by an unknown man while walking in the above area. Both men left the area before the police were contacted. The victim was treated at an area hospital for non-life threatening injuries and refused to cooperate further. No additional injuries or property damage were reported. The suspect was described as a masked man in dark-colored clothing.

Malicious Wounding [Domestic] – On May 10 at 11:25PM, officers responded to the 8500 block of Rixlew Ln. in Manassas (20109) to investigate a domestic dispute. The investigation revealed the victim, a 36-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim multiple times, choked her, and prevented her from leaving the area. At one point, the accused brandished a machete-style knife before taking the victim's phones, preventing her from contacting emergency services. Eventually, the victim was able to separate from the accused and went to a nearby business where the police were contacted. The victim was treated at an area hospital for non-life threatening injuries. Following the investigation, officers obtained arrest warrants for the accused, identified as Ronell A. **MILLER**. Attempts to locate the accused have been unsuccessful.

Aggravated Assault -- On May 10 at 9:53PM, officers responded to the 1600 block of Woodside Dr. in Woodbridge (22191) to investigate an aggravated assault. The investigation revealed the victim, a 39-year-old man, was in the above area when he was approached by two unknown men who pushed him down to the ground where he was struck and kicked multiple times. The victim was eventually able to separate from the suspects and fled to a nearby home where police were contacted. The victim was treated at an area hospital for non-life threatening injuries. No additional suspect description was provided.

Indecent Exposure – On May 11 at 10:53AM, officers responded to Neabsco Regional Park located at 15125 Blackburn Rd. in Woodbridge (22191) to investigate an indecent exposure. The investigation revealed the victim, a 27-year-old woman, was walking near the baseball fields when she was approached from behind by an unknown man. Upon turning around, the victim observed the man exposing himself and making inappropriate gestures. The victim verbally engaged the suspect who then left the area. At no point during the encounter was there any physical contact between the victim and the suspect.

Hispanic male, 25-30 years old, 5'10 – 6'0, 200lbs, with black hair and a well-trimmed goatee
Last seen wearing a white sport-jersey-style shirt and black shorts

Residential Burglary – On May 11 at 12:49PM, officers responded to investigate a burglary that was reported to have occurred at a residence located in the 14200 block of Fullerton Rd. in Woodbridge (22193) at approximately 3:39AM on May 10. The investigation revealed a masked man entered the home through a rear window that was unsecured. Video footage revealed the suspect, a black male wearing a white face mask and a red sweatshirt took cameras from inside the home before leaving.

Malicious Wounding [Domestic] – On May 9 at 10:03PM, officers responded to a residence located in the 18200 block of Thunderbolt Rd. in Dumfries (22026) to investigate a domestic dispute. The investigation revealed the victim, a 55-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the physical altercation, the accused assaulted the victim multiple times and pushed her head into a counter before the parties separated. Both parties left the residence and the police were contacted. Officers conducted a traffic stop on the accused's vehicle nearby and determined the accused was intoxicated and detained him without incident. The victim was treated at an area hospital for non-life threatening injuries. Following the investigation, the accused, identified as Donnie **CONNER II**, was arrested.

Abduction | Obtaining Goods by False Pretenses – On May 9, detectives concluded an investigation into an abduction that was reported to have occurred in the 3000 block of Old Bridge Rd. in Woodbridge (22192) on April 30. The investigation revealed the victim, a 47-year-old woman, arranged to purchase a vehicle from an acquaintance, identified as the accused and between April 16-19, paid the accused a sum of money. The accused did not provide a vehicle and on April 30, agreed to repay the victim. The two parties met in the above location where the accused brandished a firearm and threatened the victim. Eventually the accused left the area, and the victim contacted the police. No injuries were reported. Following the investigation, detectives obtained arrest warrants for the accused, identified as Zawane Mekel **PASLEY**, who was arrested by Fairfax County police on May 9.

The investigation revealed the victim, who was under the age of 13 at the time of the offense, was sexually assaulted by an acquaintance, identified as the accused, while at the above location. Following the investigation, the accused, identified as Corey Jevon **COX**, was arrested.

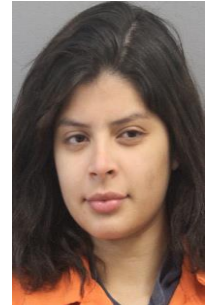

Assault & Battery on Law Enforcement Officer [LEO] – On May 11 at 4:39AM, officers responded to the area of Heathcote Blvd. and Amber Ln. in Haymarket (20169) to investigate an intoxicated individual. Upon arriving in the area, officers encountered one of the involved parties, a woman, later identified as the accused, and determined she was intoxicated before detaining her. When officers attempted to place her in a police vehicle, she kicked an officer before being res-secured and placed inside the vehicle without further incident. The officer reported minor injuries. Following the investigation, the accused, identified as Evelin **REYES MOLINA**, was arrested.

Brandishing of a firearm – On May 10 at 8:25 PM, officers responded to the area of Heathcote Blvd. near Lee Hwy. in Gainesville (20155) to investigate a brandishing. The investigation revealed the victim, a 15-year-old female juvenile, and a family member, were traveling along Heathcote Blvd. when they observed two individuals involved in an altercation in the above area. When the victim attempted to make contact with the involved individuals, one of the involved parties, identified as the accused, brandished a firearm. The victim and the family member left the area and contacted the police. When officers checked the above area, the accused and the other individual were not located. A short time later, the accused was located nearby and detained without incident. No injuries were reported. Following the investigation, the accused, identified as Lena **KURDAB**, was arrested.

The investigation revealed a Good Samaritan contacted police after locating the victim, a 5-year-old boy, walking outside with minimal clothing and unsupervised. While officers were on the scene, the victim's mother arrived at the location and met with officers. Further investigation revealed the father of the child, identified as the accused, was caring for the victim, when the victim left the residence unattended. The victim was not injured and released to the custody of known parties. Following the investigation, the accused, identified as Aflatoon **ROBERT-KONDOLOLY**, was charged.
