Updates

Serious Crash Investigation *ARREST – On May 13, investigators concluded the investigation into the crash involving a train that struck a vehicle that was reported to have occurred in the area of Milford Rd and Bristow Rd in Bristow (20136) on April 15. Further investigation revealed the driver of the Ford 350 crossed over the private train crossing and did not follow the posted road signs. Following the investigation, the accused, identified as John Edward **BATES**, was arrested by Fauquier County Sheriff's deputies.

Serious Crash Investigation [Previously Released] – On April 15 at 9:21AM, officers responded to the area of Milford Rd and Bristow Rd in Bristow (20136) to investigate a crash involving a train striking a vehicle. The investigation revealed the driver of a 2019 Ford F350, identified as a 54-year-old man, was driving westbound on Milford Dr when the vehicle crossed over a private train crossing and was struck by a southbound Amtrak passenger train. The truck was hauling a trailer at the time of the collision which separated from the vehicle. The truck came to rest on its side where the driver was subsequently extricated by Fire & Rescue services and treated at an area hospital with non-life threatening injuries. No other injuries were reported. The crossing on Milford Rd is private and has posted stop signs and warnings. The crossing is not equipped with lowering arms. The train was estimated to have been traveling approximately 74MPH at the time of the collision. The conductor sounded the train's horn prior to the crossing and stopped approximately .5-.75 miles from the crash location. Charges are pending.

Malicious Wounding [Domestic] *ARREST – On May 13, the suspect, identified as Makala Marie **BRYANT**, who was sought in connection to the malicious wounding that was reported to have occurred at a residence located in the 14400 block of Minnieville Rd. in Woodbridge (22193) on May 9, was arrested.

Malicious Wounding [Domestic] [Previously Released] – On May 9 at 6:32PM, officers responded to a residence located in the 14400 block of Minnieville Rd. in Woodbridge (22193) to investigate a domestic dispute. The investigation revealed the victim, a 33-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused assaulted the victim before striking her with a metal rake. The parties eventually separated, and the accused left the residence prior to police arriving on scene. The victim reported non-life threatening injuries. Following the investigation, officers obtained arrest warrants for the accused, identified as Makala Marie **BRYANT**. Attempts to locate the accused have been unsuccessful.

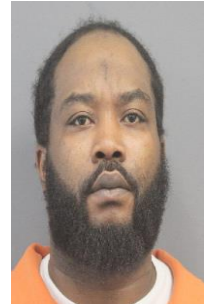
Vandalism on School Grounds – On May 13 at 11:20AM, the School Resource Officer (SRO) assigned to Gainesville High School was notified of a vandalism in the bathroom. The investigation revealed derogatory language and a vague threat towards the school was etched into a bathroom stall wall. The etchings were recently observed and reported to school personnel, who along with the SRO determined there was no credible threat to students, faculty or staff. No additional markings were reported. School personnel removed the markings.

Residential Burglary – On May 13 at 8:08PM, officers responded to the Bayvue Apartments located in the 1300 block of E. Longview Dr. in Woodbridge (22191) to investigate a burglary. The investigation revealed an unknown man entered the apartment through an open window and confronted a resident while brandishing a firearm. After a brief verbal encounter, the suspect left the residence. No property was reported missing. The suspect was described as a short black male with dreadlocks and wearing all dark-colored clothing.

Arrests

Use of Communication Systems to Facilitate Certain Offenses Involving Children –

On May 11, 2025, detectives concluded an investigation into the possession of child pornography that was reported to have occurred between June 5-6, 2024. The investigation revealed the victim, who was under the age of 15 at the time of the offense, met the accused on June 5 while in the Gainesville (20155) area and began to communicate over the phone. During the phone encounter, the accused solicited inappropriate images and proposed sexual acts to the victim on more than one occasion during the above timeframe. Following the investigation, the accused, identified as Kieron Selwyn **GREENE**, was arrested.

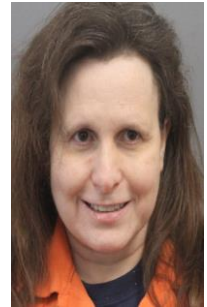

Felony Animal Cruelty Investigation – On May 10, animal control officers concluded an investigation into an animal cruelty case that was reported to have occurred at a residence located in the 7800 block of Howard St. in Manassas (20111) on February 25. The investigation revealed a local veterinarian contacted the police upon a two-month old Scottish Fold-type kitten who was brought to the office in extremely poor condition and then discharged against medical advice the following day. Further investigation revealed the owner of the kitten, identified as the accused, was providing inadequate care for the kitten and several other Scottish Fold-type cats inside the home to include giving them prescription medications that were out of date and prescribed to other cats. The living conditions inside the home were unsafe and officers initially seized eight cats from the home. A short time later, officers received additional information that all of the cats required medical treatment and in total 23 cats were seized from the residence. Based on the evaluation of the initial kitten and due to his deteriorating condition, the determination was made to humanly euthanize the animal. The other 22 cats received medical care and have all been adopted. Following the investigation, the accused, identified as Svetlana Mironva **CAULFIELD**, was arrested.
