Attempted Malicious Wounding [Domestic] – On May 15 at 12:56AM, officers responded to the Sutton Apartments located in the 2200 block of Valor Way in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed the victim, a 33-year-old man, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated.
