Updates

Officer-Involved Shooting Investigation *INVESTIGATIVE UPDATE -- The independent review into the fatal officer-involved shooting that occurred on December 5, 2024, near the 5000 block of Davis Ford Road in the Woodbridge area of Prince William County involving a member of the Prince William County Police Department has been completed. The criminal investigation surrounding the incident was conducted by the regional Critical Incident Response Team (CIRT) which is comprised of investigators from multiple law enforcement agencies in the Northern Virginia area. The completed investigation was presented by CIRT to the Honorable Amy Ashworth who is the Commonwealth's Attorney for Prince William County. After a thorough evaluation, Amy Ashworth determined that no charges will be sought against the officer involved. The investigation will now proceed with a separate, internal administrative review of the incident by the Prince William County Police Department's Office of Professional Standards. The Prince William County Police Department's Office Review Board will then conduct a final review to determine if the shooting was justified and within policy.

Officer-Involved Shooting Investigation *DECEASED IDENTIFIED [Previously Released] – Prince William County police have identified the man who died during an officer-involved shooting that occurred in the 5000 block of Davis Ford Rd in Woodbridge (22192) on December 5. The deceased was identified as Michael David BURKE, 58. The investigation into the encounter between the officer and the deceased before the shooting remains active and led by the Critical Incident Response Team (CIRT). Officer-Involved Shooting Investigation [Previously Released] - On December 5 at 5:06AM, a Prince William County police officer was involved in an officer-involved shooting on the grounds of the Department of Fire & Rescue Station 26 and the Central District Police Station located in the 5000 block of Davis Ford Rd in Woodbridge (22192) during an encounter with a man on the property. Preliminarily, a uniformed police officer was completing their work shift when the officer received information about a man in the rear parking lot of the fire station. As the officer made contact with the man, a knife was seen in the man's hand. The man began approaching the officer, waving the knife in front of him and towards the officer. The officer gave several commands to the man to drop the knife. The man did not comply and continued advancing towards the officer. At one point, the officer discharged their service weapon, striking the man in the upper body. Additional officers arrived on the scene soon after, and immediate first-aid was administered by officers and fire & rescue personnel from the nearby fire station. The man was transported to an area hospital, where he later died from his injuries. No officers, fire & rescue personnel, or other community members were injured during the incident, which remains contained to the grounds of the property. There is no active threat to the surrounding community. The identity of the deceased, preliminarily identified as an adult man, is pending and will be released once confirmed and a next of kin is notified. The Prince William County Police Department, at the request of Chief Peter Newsham, has requested the regional Critical Incident Response Team (CIRT) to oversee the investigation as an independent body. The involved officer will be placed on routine administrative leave. More information will be released when available. The investigation continues.

Strong-Arm Robbery *ARREST - While continuing to investigate the robbery that was reported to have occurred at Potomac Mills located at 2700 Potomac Mills Cl. in Woodbridge (22192) on April 18, officers obtained a detention order after identifying the suspect who struck the victim. On May 9, the suspect, identified as a **15-year-old male juvenile**, was arrested.

Strong-Arm Robbery [Previously Released] - On April 18 at 6:04PM, officers responded to Potomac Mills located at 2700 Potomac Mills Cl. in Woodbridge (22192) to investigate a robbery. The investigation revealed the victim, a 15-year-old male juvenile, was sitting in a chair inside the shopping center when he was approached by three unknown males, possibly juveniles. During the encounter, the suspects punched the victim and knocked him to the ground where they then took the victim's shoes and left the area. No injuries were reported. The suspects were described as two Hispanic males and one black male.

Attempted Residential Burglary – On May 17 at 11:57AM, officers responded to investigate an attempted burglary that was reported to have occurred at the Point at Manassas Apartments located in the 8000 block of Juliet Ln. in Manassas (20109) at approximately 11:20PM on May 16. The investigation revealed a resident of the apartment woke up to loud noises. The following morning, the resident observed damage to the front door. No entry was made, and no property was reported missing.

Malicious Wounding – On May 17 at 7:14PM, officers responded to the Potomac Mills parking lot located at 2700 Potomac Mills Cl. in Woodbridge (22192) to investigate a fight. Upon arriving in the area, officers observed multiple individuals actively fighting and separated the parties. The investigation revealed, two of the involved parties, identified as the accused, and the victim, a 17-year-old female juvenile, were involved in an altercation inside one of the stores before the altercation continued into the parking lot. During the encounter, the accused struck the victim with a glass bottle before being separated by the



officers. The victim reported non-life threatening injuries. Following the investigation, the accused, identified as Niylani Yasira **DAVIS**, was arrested.

Animal Death Investigation – On May 16 at 6:42PM, officers responded to the Manassas Mall parking lot located at 8300 Sudley Rd. in Manassas (20109) to investigate an unconscious dog. The investigation revealed the owner of the dog, identified as the accused, left the 2-year-old American Bull Dog unattended inside the vehicle. After a couple of hours when the accused went to the vehicle, the dog was located unresponsive. Animal control officers responded to the parking lot where the dog was pronounced deceased at the scene. Further investigation revealed the accused had six other dogs in his possession who were located inside the mall. The other dogs were brought to the Animal Services Center and did not appear to be injured. Following the investigation, the accused, identified as Malik Lee **DORSEY-O'BANNION**, was arrested.
