### Incidents

**Armed Robbery** – On May 18 at 12:50AM, officers responded to the 15300 block of Edgehill Dr. in Dumfries (22025) to investigate a robbery. The investigation revealed the male victims, who were between 16-20 years old, were in the above area when they were approached by three unknown men. During the encounter, the suspects took property from the victims while firearms were brandished. The suspects and the victims left the area before the police were contacted. No injuries were reported. Cell phones, a wallet and shoes were reported missing. The suspects were described as skinny black males wearing dark-colored clothing.

**Residential Burglary** – On May 19 at 10:02PM, officers responded to a residence located in the 13700 block of Restina Rd. in Bristow (20136) to investigate a burglary. The investigation revealed entry was forced into the home through the back door. Watches and an undisclosed amount of money were reported missing.

## Arrests

**Strong-Arm Robbery | Abduction** – On May 18 at 7:56AM, officers responded to a residence located in the 3700 block of Turn Back Trl. in Triangle (22172) to investigate a robbery. The investigation revealed the victim, a 23-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused took the victim’s phone and slapped her before preventing her from leaving the residence. The accused then took a second phone from the victim before the parties separated. The victim was eventually able to leave the residence and contacted the police. No injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Jaheim Carlyle **MITCHELL**, who was arrested the following day.

**Strangulation [Domestic]** – On May 19 at 10:11PM, officers responded to a residence located in the 17400 block of Cosgrove Way in Dumfries (22026) to investigate a domestic. The investigation revealed the victim, a 55-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim multiple times and put his knee on her neck. At one point during the encounter, the victim was able to separate from the accused and when she attempted to leave in a vehicle, the accused prevented her from leaving. Eventually the parties separated, and the police were contacted. The victim reported non-life threatening injuries. Following the investigation, the accused, identified as Daniel **DWAMENAH**, was arrested.

**Assault & Battery on a Law Enforcement Officer [LEO]** – On May 19 at 3:38PM, officers responded to a residence located in the 12700 block of Hunterbrook Dr. in Woodbridge (22192) to investigate a domestic dispute. Officers determined one of the involved parties, identified as the accused, was actively wanted out of another jurisdiction and when they attempted to detain him, he actively resisted. The accused struck and kicked the officers before being detained. The officers reported non-life threatening injuries. Following the investigation, identified as Clinton **OPPONG**, was arrested.

Officers located the individual, identified as the accused, in a nearby parking lot where they determined he was intoxicated. When officers attempted to detain the accused, he actively resisted and spat on two separate officers while also making threats towards the officers. No injuries were reported. Following the investigation, the accused, identified as Steven Douglas **HARVEY**, was arrested.
