Incidents

Murder Investigation – On May 21 at 5:13PM, officers responded to the 14200 block of Smoketown Rd. in Woodbridge (22192) to investigate a shooting. When officers initially arrived in the above area, there were no immediate signs of injuries. While checking the secluded wooded area behind the shopping complex, officers ultimately located three adult males with gunshot wounds. Fire and rescue personnel responded and pronounced the 29-year-old victim deceased at the scene. The other two victims, who were both 42 years old, were transported to area hospitals with non-life threatening injuries. The investigation revealed the 29-year-old man was in the above area when he was approached by a man he had previously encountered, identified as the accused. During the encounter, a verbal altercation between the two men escalated before multiple rounds were fired which fatally struck the 29-year-old man and wounded the other two men. The suspect left the area prior to police arriving on scene. No additional injuries or property damage were reported. Detectives located the accused the following morning in the Fredericksburg area where he was taken into custody without incident. **This incident was not random.** Following the investigation, the accused, identified as Dean **CAMPBELL**, was arrested.

Arrests

Strangulation [Domestic] – On May 21 at 5:27pm, officers responded to a residence located in the 3700 block of Mainsail Cove in Triangle (22172) to investigate a domestic dispute. The investigation revealed earlier that day, the accused entered the bedroom of the victim, identified as a 17-year-old female juvenile, without her permission. During the encounter, the accused, who was known to the victim, struck her and grabbed her neck before taking her medication and an electronic device. When a family member intervened, the accused left the residence. While investigating the incident, officers determined additional choking incidents occurred between March 1 and April 30. The victim reported non-life threatening injuries. Following the investigation, the accused, identified as Shyreese **BROWN Jr.**, was arrested.

Reckless Handling of a Firearm – On May 22 at 4:12AM, officers responded to the 7400 block of Hillwood Dr. in Gainesville (20155) to investigate a shots fired call. The investigation revealed a group of individuals were in the wooded area near the above location when a man and a woman, identified as the accused, fired rounds into the woodline. When officers arrived in the area, they located the accused and determined the woman was in possession of a firearm while intoxicated. Officers took possession of the firearm and detained both of the accused without incident. No injuries or property damage were reported. Following the investigation, both of the accused, identified as Antonio Bellfonte **JOHNSON** and Haley Marie **MAY**, were arrested.

Gambling Operation Investigation – On May 19, detectives concluded an investigation into an illegal gambling operation being operated at 7393 Miramar Dr. in Manassas (20109), where slot machines and other gambling machines were in use. On May 11, while investigating an unrelated incident, officers went inside The Washing Company where they observed a false wall connected to an adjoining vacant business open up and several gambling machines inside the apparent vacant business. Further investigation revealed the laundromat had screens at the front desk with camera footage from the adjoining room where gambling was actively being conducted. Detectives obtained search warrants for the businesses and recovered 30 gambling machines and an undisclosed amount of money, along with other items of evidence. Further investigation revealed there were three suspects involved with the gambling operation, and following the investigation detectives obtained warrants for their arrest. Between May 16-19, the three suspects, identified as Nasir **JAFRI**, Joel Enrique **RIVERA-RIVERA**, and Giovanni Alfredo **RECALDE**, were arrested.
