#### **Director's Report**

- The Human Rights office has an inventory of 24 open cases.
- On April 23<sup>rd</sup>, the HRO held a Webinar focused on fair housing. 54 people registered and 28 people participated. The webinar featured:
  - Barksdale Haggins from Fairfax County Government, who provided an overview of the Fair Housing Act.
  - Mahalia “Mally” Dryden-Mason from Loudoun County presented case studies and examples of housing discrimination.
  - Joan Duckett, Director of Prince William County Housing and Development, provided resources for assistance and support.
- On May 20, 2025, Director Torres will participate in the Fairfax County Housing Summit.
- The Spring Newsletter will be distributed in the coming weeks.

Additionally, Commissioner BruMar completed CIT training with the Police Department.

Curtis Porter – Chair Porter will meet with the Chief of Police and Prince William County Public Schools (PWCPS) to discuss potential collaboration efforts to address hate and bias issues within Prince William County schools.
