### Updates

**Fatal Crash Investigation \*DECEASED IDENTIFIED** – Additional information is being publicly disclosed to solicit information into the fatal hit and run that occurred in the intersection of Lee Hwy. and Virginia Oaks Dr. in Gainesville (20155) on June 5. Investigators confirmed the pedestrian involved was a 44-year-old Maryland man. Further investigation revealed the striking vehicle involved was possibly a white vehicle with front end damage. **Crash investigators are asking anyone who may have witnessed this crash to contact police.** The investigation continues.

The deceased pedestrian was identified as Timothy Scott **RINEHART**, 44, of Laurel, MD

**Fatal Hit & Run Crash Investigation [Previously Released]** – On June 5 at 1:57AM, officers responded to the intersection of Lee Hwy. and Virginia Oaks Dr. in Gainesville (20155) to investigate a hit and run crash involving a pedestrian. The investigation revealed the driver of an unknown vehicle was traveling northbound on Lee Hwy. when the vehicle struck a pedestrian within the above intersection who was attempting to cross Lee Hwy. The striking vehicle did not stop and left the scene. The pedestrian was pronounced deceased at the scene. No further information on the driver or striking vehicle is available at this time. The identity of the deceased will be released once a next-of-kin has been notified. **Investigators with the Crash Investigation Unit are asking anyone who may have witnessed this crash to contact police.** The investigation continues.

The investigation revealed the victim, a 23-year-old man, and an acquaintance, identified as the accused, were involved in a physical altercation. During the encounter, the accused placed his hands around the victim's. The struggle continued until the parties eventually separated. Minor injuries were reported. Following the investigation, officers obtained an arrest warrant for the accused, identified as Angel Manuel **REYES-TLATELPA**. Attempts to locate the accused were unsuccessful.

## Arrests

**Aggravated Malicious Wounding** – On June 9 at 1:01AM, officers responded to the 17000 block of Dumfries Rd. in Dumfries (22025) to investigate a shooting. The investigation revealed the victim, a 40-year-old man, was with a group of individuals when an altercation escalated. During the encounter, someone in the group, identified as the accused, fired a round, striking the victim. The parties dispersed and left the area. The victim went to a local business where the police were contacted. The victim was treated at an area hospital for a non-life threatening injury. While investigating the incident, officers located the accused who was detained. Shell casings were recovered in the above area. Following the investigation, the accused, identified as Bobby Wynard **HARRIS**, was arrested.

**Armed Robbery** – On June 8 at 4:10AM, officers responded to the 14400 block of Telegraph Rd. in Woodbridge (22192) to investigate a robbery. The investigation revealed the victim, a 27-year-old man, and the driver of another vehicle, later identified as the accused, were involved in a vehicle crash near the above area. During the encounter, the accused brandished a firearm and forced the victim from their vehicle before driving into a nearby parking lot. The accused then returned to the victim's location and demanded property including the victim's cell phone as police were being contacted. Officers arrived and detained the accused without incident. No injuries were reported. Following the investigation, the accused, identified as Craig James **KNIGHT**, was arrested. While being processed, the accused struck an officer with his head. The officer was not injured.

**Abduction [Domestic]** – On June 7 at 1:26PM, officers responded to a residence located in the 13700 block of Langstone Dr. in Woodbridge (22193) to investigate a domestic dispute. The investigation revealed the victim, a 47-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim and grabbed her neck. At one point, the accused took the victim's phone and keys before he physically prevented her from leaving the home. The victim eventually went to a neighboring residence where the police were contacted. The accused took the victim's vehicle and left before officers arrived on scene. While checking the area, officers located the victim's unoccupied vehicle a short distance away. Non-life threatening injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Carlyle Matthew **MITCHELL**, who was arrested on June 9.
