

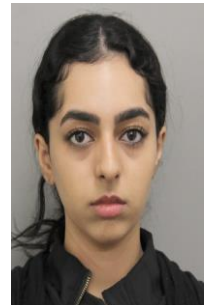


## DAILY INCIDENT REPORT

June 11, 2025

### Updates

**Fatal Crash Investigation \*ARREST** – On June 10, crash investigators charged the driver of the 2021 Toyota Highlander involved in the fatal crash that occurred at the intersection of Minnieville Rd. and Summit School Rd. in Woodbridge (22192) on May 27. The investigation revealed the accused was traveling at more than double the posted speed limit in an active work zone at the time of the collision. The vehicle proceeded into the intersection against a red traffic signal before striking the other vehicle. The 45-year-old female driver of the other vehicle involved was killed. Following the investigation, the accused, identified as Wania Mussarat **SHAIKH**, was arrested.

**Fatal Crash Investigation [Previously Released]** – On May 27 at 9:30AM, officers responded to the intersection of Minnieville Rd. and Summit School Rd. in Woodbridge (22192) to investigate a crash. The investigation revealed the driver of a 2021 Toyota Highlander was traveling northbound on Minnieville Rd., and the driver of a 2020 Honda Accord was traveling southbound. With a flashing amber traffic signal, the driver of the 2020 Honda initiated a left turn across the northbound lanes of Minnieville Rd. towards Summit School Rd., and the vehicles collided. The driver in the 2020 Honda was extricated from the vehicle and transported to an area hospital, where she later died. The driver of the 2021 Toyota was treated at an area hospital for non-life threatening injuries. Investigators determined that alcohol and drugs are not factors for either driver. Charges are pending as the investigation continues.

## Incidents

**Death Investigation** – On June 10 at 3:39PM, officers responded to Bull Run Plaza located in the 11700 block of Sudley Manor Dr. in Manassas (20109) to investigate a death. The investigation revealed a 54-year-old woman was found unconscious inside a vehicle in the parking lot and pronounced deceased. Preliminarily, there were no signs of foul play. The body was transported to the Medical Examiner's Office for an autopsy to determine the cause and manner of death. At this time, there is no threat to the community concerning the death. More information will be released as necessary.

**Strong-Arm Robbery** – On June 9 at 10:54PM, officers responded to the 4700 block of Darbydale Ave. in Woodbridge (22193) to investigate a robbery. The investigation revealed the victim, a 30-year-old man, was approached by a group of men in the above area. During the encounter, two of the men struck the victim before taking his backpack and leaving the area. Non-life threatening injuries were reported. The suspects were not located.

## Arrests

**Strangulation [Domestic]** – On June 10 at 3:24PM, officers responded to investigate a domestic dispute that was reported to have occurred at a residence located in the 1400 block of Deerfield Ln. in Woodbridge (22191) earlier that day. The investigation revealed the victim, a 20-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation with that escalated. During the encounter, the accused grabbed the victim and pushed her against a wall before the parties separated. While investigating the incident, officers determined two additional domestic incidents occurred since April 2025 involving the accused assaulting the victim and also sending her threatening text messages. Non-life threatening injuries were reported. Following the investigation, the accused, identified as Christian **GUERRERO**, was arrested.
