Armed Robbery *ADDITIONAL ARREST – On June 10, the second suspect sought in connection to the robbery that was reported to have occurred in the 3600 block of Golf Side Circle, in Woodbridge (22192) on April 2, was arrested. While continuing to investigate the incident, officers identified the male suspect and obtained warrants for his arrest. On June 10, following the investigation, the male suspect, identified as Tyjuan Cattrell **SMITH**, was arrested. Another suspect was previously arrested in connection with this investigation.

Armed Robbery *ARREST [Previously Released] – On May 22, the female suspect wanted in connection to the robbery that was reported to have occurred in the 3600 block of Golf Side Circle, in Woodbridge (22192) on April 2, was arrested. While continuing the investigation, officers identified the female suspect and obtained warrants for her arrest. Following the investigation, the female suspect, identified as Saniyah Ayan Quash **WESLEY**, was arrested. The investigation remains active as officers attempt to identify the male suspect.

Armed Robbery [Previously Released] – On April 2 at 7:25PM, officers responded to the 3600 block of Golf Side Circle, in Woodbridge (22192) for a report of a robbery. The investigation revealed a food delivery driver was threatened and robbed by an unknown man and woman. During the encounter, the male suspect implied he was armed before taking the food and leaving the area with the female suspect. The victim also left the area and reported the incident to the police. No injuries were reported. Officers searched the area for the suspects who were not located.

Felony Hit & Run | Armed Robbery – On June 16 at 5:23AM, officers responded to the 2000 block of Daniel Stuart Sq. in Woodbridge (22191) to investigate an assault. The investigation revealed the victim, a 26-year-old man, observed multiple unknown men approach a female acquaintance and demand her property. When the victim attempted to intervene, the suspects assaulted him and brandished a firearm before taking his property. A vehicle then began driving towards the group and drove over the victim, who was on the ground. The vehicle stopped shortly after, and then the suspects entered the vehicle before they all left the area. The victim was transported to an area hospital with non-life threatening injuries. The investigation continues as officers attempt to identify the suspects.

Suspect Descriptions:

A white male with a blonde hair, a mustache, and a tribal tattoo on the left side of his face
Last seen wearing a black fitted cap, a white t-shirt, blue sweatpants and all-white Jordan sneakers

A Hispanic male who was bald, had a goatee, with multiple facial tattoos
Last seen wearing a blue t-shirt, light blue shorts and Adidas tennis shoes

A black male with a tattoo on his left hand
Last seen wearing a ski-style mask, glasses, a grey sweat shirt and purple pants

Commercial Burglary – On June 15 at 1:16AM, officers responded to the OZE Tobacco and Vape store located at 9755 Liberia Ave. in Manassas (20112) to investigate a burglary. Video surveillance revealed three unknown individuals forced entry into the business through the front glass door. Upon entering the business, the suspects took several tobacco and vape products before leaving the area. Officers and a police K-9 searched the area for the suspects, who were not located.

Suspect Descriptions:

A male with a small build

Last seen wearing a dark-colored mask and clothing, bright colored gloves and carrying a backpack

A short individual with a small build and long black hair

Last seen wearing all black-colored clothing, grey/black shoes and carrying a large backpack

A tall male with a heavy build

Last seen wearing a grey/red fitted hat, a red mask, a dark-colored zip-up jacket, light-colored sweatpants and dark-colored shoes

Attempted Residential Burglary – On June 13 at 9:08AM, officers responded to The Fairmont retirement community located at 9852 Fairmont Ave. in Manassas (20109) to investigate an attempted burglary. The investigation revealed that sometime in the early morning hours, a resident of an apartment woke to a loud noise at the front door. At that time the resident observed an unknown individual outside of the door before the individual left the area. Later that morning the resident observed the front door handle was damaged. No entry was made, and no property was reported missing.

Arrests

Armed Robbery – On June 14 at 1:14AM, officers responded to 7100 Sudley Rd. in Manassas (20109) to investigate an armed robbery. The investigation revealed the victim, a 32-year-old man, met two unknown men earlier in the night and given them a ride to the above location where a third unknown man entered the vehicle. Shortly after, one of the men grabbed the car keys out of the ignition before brandishing a firearm towards the victim who grabbed onto the firearm. A struggle over the gun ensued and a round was discharged before the victim was struck by the suspects. The victim eventually left the vehicle, and the suspects drove the vehicle out of the area. Non-life threatening injuries were reported by the victim. No property damage or additional injuries were reported. The vehicle was later recovered; however, the suspects were not initially located. While continuing the investigation, detectives identified one of the suspects as Christian Anthony **BLANCO** who was arrested later that evening. The investigation continues as detectives attempt to identify the other two suspects involved in the incident.

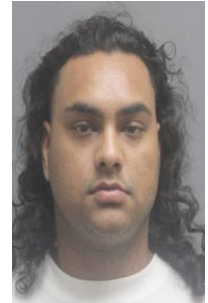

Strangulation [Domestic] – On June 14 at 11:343PM, officers responded to a residence located in the 6200 block of Oakland Dr. in Woodbridge (22192) to investigate a domestic dispute. The investigation revealed the victim, a 26-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim with different objects before grabbing her neck and pushing her to the ground. The parties eventually separated and the police were contacted. Non-life threatening injuries were reported. Following the investigation, the accused, identified as Murad Ali **MOHAMMED**, was arrested.



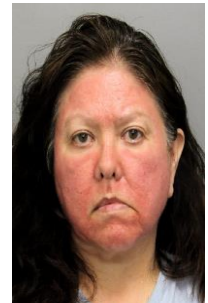

Felony Child Neglect – On June 14 at 8:47PM, officers responded to the Comfort Suites located at 14525 Gideon Dr. in Woodbridge (22192) to investigate a found child. The investigation revealed the victim, a 2-year-old boy, was found unattended in the lobby of the hotel by an employee. Officers determined the victim's grandmother, identified as the accused, left the child unattended in a room which the victim left without supervision. Eventually, the accused exited her room looking for the child and encountered the officers. The child did not appear injured and was released to the custody of known parties. Following the investigation, the accused, identified as Thelma C. **FARLEY**, was arrested.
