Arrests

Malicious Wounding – On June 2 at 8:16PM, officers responded to the Potomac Vista Apartments located in the 14100 block of Bay Vista Dr. in Woodbridge (22191) to investigate an assault. The investigation revealed the victims, a 19-year-old man and an 18-year-old man, were involved in a verbal altercation with other individuals. During the encounter, a third man, later identified as the accused, attempted to intervene leading to a physical altercation where the accused pulled out a box-cutter style knife and cut both victims. The parties separated and both victims were **treated at an area hospital for** non-



life threatening injuries. Following the investigation, officers obtained arrest warrants for the accused, identified as Joshua Lavontae **GINGRICH**, who was arrested on June 14.

Indecent Liberties by Custodian – On June 4 at 3:01PM, the School Resource Officer assigned to Forest Park High School located at 15721 Forest Park Dr. in Woodbridge (22193) began an investigation into a teacher exposing himself. The investigation revealed earlier that day, the teacher, identified as the accused, was seated at his desk inside a classroom with students present when more than one student observed the accused exposing himself and making inappropriate gestures. The students reported it to school personnel. Following the investigation, officers obtained arrest warrants for the accused, identified as Coy Robert **DUBIK**, who was arrested on June 16.
