Incidents

Fatal Crash Investigation – On June 21 at 10:30PM, officers responded to the area of Dumfries Rd. and Snowfall Dr. in Manassas (20112) to investigate a crash. The investigation revealed the driver of a 2018 Ford Mustang was traveling northbound on Dumfries Rd. in the southbound lanes when the vehicle struck a 2009 Chevrolet Malibu Maxx head-on. Both vehicles rotated counterclockwise, and the Mustang came to rest in the median while the Malibu stopped in the roadway. Both drivers were extricated from the vehicles and transported to area hospitals with life-threatening injuries. The driver of the Malibu received treatment and is expected to recover. On June 22, crash investigators were notified that the driver of the Mustang had died from injuries sustained during the crash.

Identified:

The deceased driver of the 2018 Ford Mustang was identified as Gean C. **ALVAREZ**, 22, of Quantico The driver of the 2009 Chevrolet Malibu Maxx was identified as a **51-year-old woman** of Dumfries

Strangulation [Domestic] - On June 22 at 3:34AM, officers responded to a residence located in the 7800 block of Sharpsburg Ct. in Manassas (20109) to investigate a domestic dispute. The investigation revealed the victim, a 22-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused bit the victim on the hands before grabbing her neck. The parties eventually separated, and the accused left the area in a white van. Non-life threatening injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Brayan Josue **QUIJADA-ABREGO**. Attempts to locate the accused have been unsuccessful.

Assault by Mob – On June 23, the School Resource Officer (SRO) assigned to Forest Park High School located at 15721 Forest Park Dr. in Woodbridge (22193) concluded an investigation into a fight that occurred on school grounds on May 23. The investigation revealed two male students, a 14 and 15-year-old, were assaulted by multiple other juveniles while waiting for the school bus outside the building. The victims were struck on the head before the parties dispersed. Further investigation revealed the fight occurred due to a previous altercation between the parties involved.
