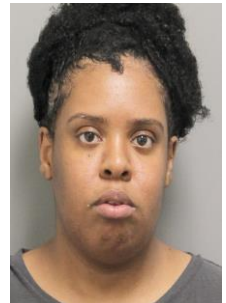

The investigation revealed the victims, a 31-year-old man and a 30-year-old woman, were speaking to a neighbor, identified as the accused, over an ongoing issue. During the encounter, the accused sprayed both victims with an irritant substance before the parties separated. Minor injuries were reported.
