### Incidents

**Shooting Investigation** – On July 7 at 5:22AM, officers initially responded to investigate a shooting that was reported to have occurred in the 7400 block of Stream Walk Ln. in Manassas (20109) earlier that morning. The preliminary investigation revealed an 18-year-old man sustained gunshot related injuries during an alleged incident in a wooded area on Stream Walk Ln. near I-66. When officers checked the area, no evidence of a shooting was located. The man was treated for a non-life threatening injury at an area hospital where police were contacted. The man refused to cooperate further with the officers. No property damage or additional injuries were located.

**Abduction [Domestic]** – On July 4 at 10:39AM, officers responded to the intersection of Springwoods Dr. and Chaucer Ln. in Woodbridge (22192) to investigate an abduction. The investigation revealed the victim, a 22-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated while stopped at the above intersection. During the encounter, a physical altercation ensued before the accused brandished a firearm and prevented the victim from getting out of the vehicle. Eventually, the accused got out of the vehicle and the victim contacted the police. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Elliot **MCDONALD**. Attempts to locate the accused have been unsuccessful.

**Reckless Handling of a Firearm** – On July 5 at 6:42PM, officers responded to the area of Apache Ridge and Halterpath Trl. in Manassas (20109) to investigate a shots fired call. The investigation revealed a home on Apache Ridge and a vehicle occupied by a 19-year-old man were struck during an exchange of gunfire. Officers located the vehicle and determined rounds were fired towards the vehicle and from within the vehicle. Officers also located shell casings in the grassy area of Apache Ridge and Halterpath Trl. No injuries or additional property damage were reported.

**Reckless Handling of a Firearm** – On July 4 at 10:25PM, officers responded to Lancaster Mill Park located at 13800 Pop Moubry Pl. in Woodbridge (22191) to investigate a shots fired call. The investigation revealed multiple gunshots were fired from a vehicle that was leaving the parking lot and was last seen traveling south on Pop Moubry Pl. Officers also located shell casings in the roadway. No injuries or property damage were reported. While investigating the incident, officers located an unoccupied vehicle in the parking lot with firearms and drug paraphernalia inside.

**Residential Burglary** – On July 6 at 4:23PM, officers responded to a residence located in the 3500 block of Sherbrooke Cl. in Woodbridge (22192) to investigate a burglary. The investigation revealed the homeowner located an unknown man inside his home. The homeowner followed the suspect outside where another unknown man was waiting by a fence. Both suspects then left the area. Officers and a police K-9 searched the area for the suspects who were not located. Entry was made into the home through the rear door which was found unsecured. No property was reported missing.

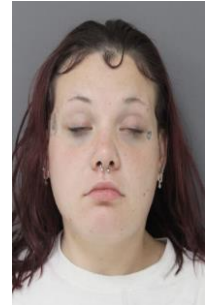

## Arrests

**Attempted Malicious Wounding [Domestic]** – On July 3 at 1:47PM, officers responded to investigate a domestic dispute that was reported to have occurred at a residence located in the 9400 block of Lafayette Ave. in Manassas (20109) earlier that morning. The investigation revealed the victim, a 24-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused prevented the victim from leaving the home and grabbed her neck before brandishing a firearm. The parties eventually separated. Non-life threatening injuries were reported. Following the investigation, the accused, identified as Martin De Jes **VICTORIO MORALES**, was arrested on July 4.

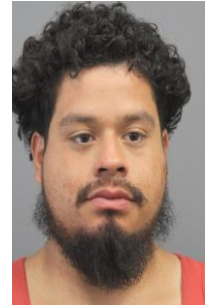

While officers were assisting fire and rescue personnel, the intoxicated individual, identified as the accused, shoved an officer. When officers attempted to detain the accused, he continued to resist and was detained without incident after a brief struggle. No injuries were reported. **Assault & Battery on a Law Enforcement Officer [LEO]** – On July 4 at 10:32AM, officers responded to the 16900 block of Old Stage Rd. in Dumfries (22025) to investigate a larceny. As officers were investigating the incident, a woman, later identified as the accused, attempted to interfere. During the encounter, officers determined the accused was intoxicated and attempted to detain her. The accused briefly ran from officers and then scratched an officer before being detained without further incident. The accused initially provided officers with false identifying information and was found in possession of suspected illegal drugs. Minor injuries were reported. Following the investigation, the accused, identified as Monae Brentanie **MCWANE**, was arrested.
