Updates

Felony Hit & Run Crash Investigation *ARREST – On July 7 at 1:47PM, officers responded to the Bayvue Apartments located in the 1300 block of E. Longview Dr. in Woodbridge (22191) to investigate an unconscious individual. Officers located the individual, later identified as the accused, who had regained consciousness in the stairwell of the building. During the encounter, the accused pushed an officer and attempted to flee the area. Officers followed the accused and detained him a short distance away. No injuries were reported. The accused then attempted to provide officers with false identifying information and was also found in possession of suspected illegal drugs. Officers further determined the accused was actively wanted in connection with a hit and run crash that was reported to have occurred on March 18 and several other property crimes investigations. Following the investigation, the accused, identified as Jaquan Malik **FITCHETT**, was arrested.

Felony Hit & Run Crash Investigation [Previously Released] – On March 18 at 7:24AM, officers responded to the area of Yorkshire Ln. near Old Centreville Rd. in Manassas (20111) to investigate a multi-vehicle crash. Prior to the police arriving at the scene, the driver of the striking vehicle, later identified as the accused, left the area on foot. The investigation revealed the accused side-swiped a vehicle before striking another vehicle head-on. A 48-year-old woman driving the other vehicle was treated at an area hospital for non-life threatening injuries. While investigating the incident, officers determined the accused was operating a stolen vehicle. Following the investigation, officers obtained arrest warrants for the accused, identified as Jaquan Malik **FITCHETT**. The accused is also wanted on unrelated charges. Attempts to locate the accused have been unsuccessful.

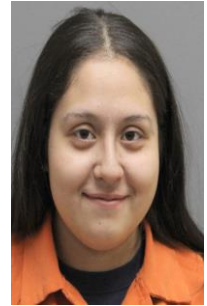

Felony Hit & Run [Previously Released] – On June 23 at 5:58PM, detectives in the 10400 block of Sudley Manor Dr. in Manassas (20109) made contact with the occupants of a vehicle located behind a business. During the encounter, suspected illegal narcotics were observed. As detectives continued their investigation, the driver of the vehicle, later identified as the accused, reversed the vehicle and struck a police vehicle before fleeing the area. Detectives located the vehicle in the area of King George Dr. where it was determined the accused had used the vehicle without the owner's permission. No injuries or additional property damage were reported. Following the investigation, detectives obtained arrest warrants for the accused, identified as Jessica Siomara **RIVERA-VANEGAS**. Attempts to locate the accused have been unsuccessful.

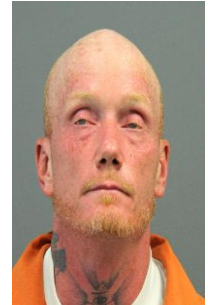
