# DAILY INCIDENT REPORT

## Incidents

**Abduction [Domestic]** – On July 8 at 8:42PM, officers responded to the 3400 block of Belleplain Ct. in Dumfries (22026) to investigate a domestic dispute. The investigation revealed the victim, a 60-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused prevented the victim from leaving the home before striking her with a kitchen utensil and then leaving the residence. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Malvin **JOHNSON.** Attempts to locate the accused have been unsuccessful.

**Strangulation [Domestic] –** On July 8 at 4:39PM, officers responded to investigate a domestic dispute that was reported to have occurred in the 8300 block of Sudley Rd. in Manassas (20109) in May 2025. The investigation revealed the victim, a 21-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim before grabbing her neck multiple times. The parties eventually separated. While investigating the incident, officers determined there was an additional incident in May where the accused grabbed the victim's neck. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Juan Miguel **GARCIA ANDRADE**. Attempts to locate the accused have been unsuccessful.

**Strong-Arm Robbery** – On July 8 at 4:44PM, officers responded to the 14000 block of Worth Ave. in Woodbridge (22192) to investigate a robbery. The investigation revealed the victim, a 68-year-old woman, was approached by an unknown woman in a parking lot. During the encounter, the suspect forcefully grabbed the victim's wallet before leaving on foot. No injuries were reported. Good Samaritans in the area followed the suspect who returned the victim's property without incident. The suspect was last seen getting into a blue 4-door sedan driven by another individual and leaving the area.

#### Suspect Description:

A Hispanic female, in her 30's, approximately 5'5", with a medium build, long brown hair Last seen wearing white-colored clothing and shoes

### Arrests

**Strong-Arm Robbery** – On July 8 at 2:13PM, officers responded to the 2000 block of Daniel Stuart Sq. in Woodbridge (22191) to investigate a robbery. The investigation revealed the victim, a 56-year-old man, and an acquaintance, identified as the accused, were involved in a verbal altercation while inside a vehicle. During the encounter, the accused struck the victim and took his phone. When the victim attempted to flag down a nearby officer, the accused exited the vehicle and initially fled before being detained without further incident. Minor injuries were reported. The accused was found in possession of suspected illegal



drugs. Following the investigation, the accused, identified as Analeyssy Stephanie **BALBUENA**, was arrested.
