Strangulation [Domestic] *ARREST – On July 8, the suspect sought in connection to the domestic dispute that was reported to have occurred at a residence located in the 7800 block of Sharpsburg Ct. in Manassas (20109) on June 22, was arrested. The accused, identified as Brayan Josue **QUIJADA-ABREGO**, was taken into custody in Fairfax County.

Strangulation [Domestic] [Previously Released] – On June 22 at 3:34AM, officers responded to a residence located in the 7800 block of Sharpsburg Ct. in Manassas (20109) to investigate a domestic dispute. The investigation revealed the victim, a 22-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused bit the victim on the hands before grabbing her neck. The parties eventually separated, and the accused left the area in a white van. Non-life threatening injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Brayan Josue **QUIJADA-ABREGO**. Attempts to locate the accused have been unsuccessful.

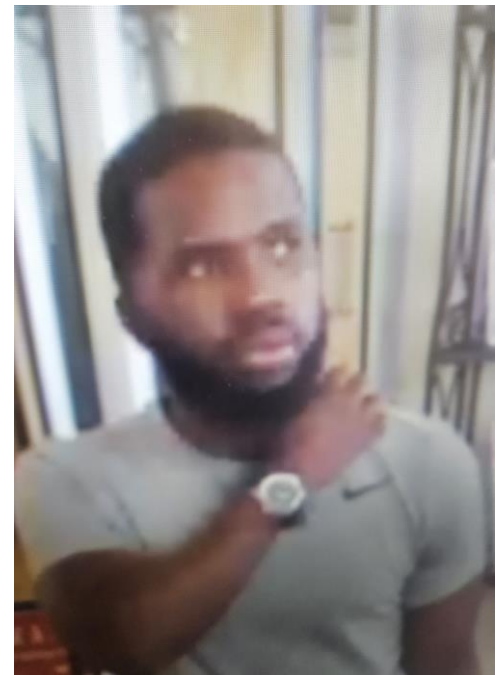
Reckless Handling of a Firearm – On July 9 at 12:08PM, officers responded to investigate a shots fired call that was reported to have occurred in the area of Ashton Ave. near Coverstone Dr. in Manassas (20109) on the evening of July 8. The investigation revealed the victim, a 38-year-old man, was in the 11100 block of Balls Ford Rd. when he was approached by a man he had previously encountered. During the encounter, the man struck the victim multiple times before the parties separated. The victim left the area on foot and was walking on Ashton Ave. when a vehicle began following him. At one point, rounds were reportedly fired from the vehicle towards the victim before the vehicle left the area. The victim was not struck and contacted police the following day. No other reports of shots fired were reported. No property damage or other injuries were reported.

Sexual Assault Investigation – On July 9 at 11:56AM, officers responded to Hobby Lobby located at 14000 Shoppers Best Way in Woodbridge (22192) to investigate a sexual assault. The investigation revealed the victim, an 80-year-old woman, was shopping inside the store when she was approached from behind by an unknown man. During the encounter, the suspect pressed up against the victim and inappropriately touched her. When the victim confronted the suspect, he left the business. No injuries were reported.

Arrests

Stalking | Computer Trespass | Arrest of Department Member – On July 9, investigators with the Prince William County Police Department arrested a department member in connection to an ongoing investigation which began in June 2025. The investigation revealed on multiple occasions, the accused, who was a sworn law enforcement officer with the police department at the time, accessed law enforcement databases to obtain identifying information on the victim, identified as an adult man, who was known to a female acquaintance of the accused. Through the investigation, the accused was determined to have accessed the Virginia Criminal Information Network [VCIN], once in 2023 and four times in 2024 to obtain information on the victim. The accused was reportedly on duty at the time of each incident, and did not have a criminal justice reason needed to access the information. Furthermore, the accused was determined to have been in the area of the victim's residence on more than one occasion over a 15-month timeframe. Once the allegations were brought to the attention of police, the accused was relieved of his police authority, and both an administrative and criminal investigation into the accusations were launched by the Police Department's Office of Professional Standards and Criminal Investigations Division. At the time of the report, the accused held the rank of police officer with more than 6 years of service. On July 9, following the investigation, the accused, identified as Godson **VONDEE**, was arrested. The accused has been placed on administrative leave while the criminal matter proceeds through court.

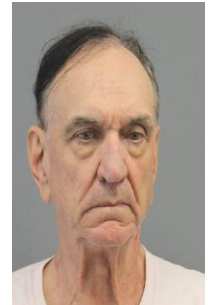

Strangulation [Domestic] – On July 9 at 3:47PM, officers responded to The Landings at Markham's Grant Apartments located in the 2600 block of Penbury Ct. in Woodbridge (22191) to investigate a domestic dispute. The investigation revealed the victim, a 57-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused pushed the accused down before grabbing her neck. The parties eventually separated, and the police were contacted. The victim was treated at an area hospital for non-life threatening injuries. Following the investigation, the accused, identified as Arthur Joseph **ROWE**, was arrested.

Assault & Battery on a Law Enforcement Officer [LEO] – On July 10 at 1:15AM, officers responded to a residence located in the 8700 block of Elsing Green Dr. in Manassas (20112) for a person in crisis. While investigating the incident, the accused threw a bottle at an officer and struck more than one officer multiple times, breaking an officer's glasses. The accused also spat on one of the officers before being detained without further incident. Minon injuries were reported. Following the investigation, the accused, identified as Cedric Terrell-Octavias **SELDON**, was arrested.
