Incidents

Aggravated Assault – On July 11 at 7:09PM, officers responded to the 9500 block of Linton Hall Rd in Bristow (20136) to investigate a possible assault. The investigation revealed a 56-year-old man was located along a walking path in the above area. The man had reportedly sustained significant injuries and was treated at an area hospital. No further information is immediately available as to how the man sustained his injuries.

Reckless Handling of a Firearm – On July 11 at 3:09PM, officers responded to the County Center Crossing Apartment located in the 13000 block of Patamon Way in Woodbridge (22192) to investigate a reckless handling. The investigation revealed multiple gunshots were heard in the area. No injuries or property damage were reported. Officers located shell casings on the third and fourth floor of the complex. No suspect description was provided.

Residential Burglary – On July 13 at 10:44PM, officers responded to investigate a burglary that was reported to have occurred at a residence located in the 1600 block of Pinewood Ct in Woodbridge (22191) earlier that evening. The investigation revealed the homeowner was gardening in their yard when they were approached by an unknown woman. During the encounter, a second woman approached, possibly entering the unsecured home. Later, the homeowner found multiple drawers had been rummaged through. No property was reported missing. Both women were described as Middle Eastern wearing long dresses and were last seen getting into a newer model SUV being driven by an unknown individual, possibly a male.

Residential Burglary – On July 11 at 6:30PM responded to investigate a burglary that was reported to have occurred at the County Center Crossing Apartment located in the 13000 block of Patamon Way in Woodbridge (22192) between July 7 and July 11. The investigation revealed during this timeframe, entry was made into an apartment through the front door. Two firearms were reported missing. No suspect description was provided.

Attempted Residential Burglary – On July 13 at 12:57AM, officers responded to a residence located in the 10200 block of Cub Run Ct in Manassas (20109) to investigate an attempted burglary. The investigation revealed an unknown man was attempting to enter the home through a second story window. Upon being seen, the man fled the area. During the investigation, officers learned a similar, unreported incident had occurred in June possibly involving the same suspect. No entry was made into the home, and no property was reported missing. The suspect was described as a Hispanic male, late teens or early 20s, with black curly hair wearing jeans and mask, no shirt.

Attempted Residential Burglary – On July 12 at 9:32PM, officers responded to a residence located in the 9800 block of Earls Ferry Cir in Bristow (20181) to investigate an attempted burglary. The investigation revealed forced entry was attempted into the home through the front door which was found damaged. The homeowner was home at the time and immediately called the police. No entry was made into the home, and no property was reported missing. A police K-9 checked the area for the suspect who was not located. No suspect description was provided.

Arrests

Aggravated Sexual Battery – On July 12 at 11:50AM, officers responded to the Sams Club located at 14050 Worth Ave in Woodbridge (22192) to investigate a sexual assault. The investigation revealed the victim, a 6-year-old girl, was shopping in the store with her family when she was approached by an unknown man, later identified as the accused. While the victim's mother was turned away, the accused inappropriately touched the victim. The victim's mother confronted the accused who left the business and was last seen getting into a vehicle. A license plate of the vehicle was obtained, and the accused



was located at his residence. Following the investigation, the accused, identified as Justin Van **NGUYEN**, was arrested.

Reckless Handling of a Firearm – On July 11 at 9:35PM, officers responded to a residence located in the 14200 block of Birchdale Ave in Woodbridge (22191) to investigate a person-in-crisis armed with a weapon. The investigation revealed a resident of the home, later identified as the accused, was experiencing a crisis and had reportedly fired multiple inside the home through a rear glass door. Officers arrived and detained the accused without further incident. No injuries or other property damage was reported. Following the investigation, the accused, identified as Lonnie **CHASE**, was charged and taken to an area medical facility for further treatment and evaluation.

Burglary to a School – On July 13 at 5:02PM, officers responded to Unity Reed High School located at 8820 Rixlew Ln in Manassas (20109) to investigate a burglary. The investigation revealed an unknown man, later identified as the accused, had entered the school around 3:00AM and damaged property inside the building. Later in the day, the accused confronted members attending church services at the location prompting the call to police. Officers arrived and detained the accused who resisted while in-custody and initially provided a false ID to police. While reviewing security footage, the accused



was seen entering the school and had remained inside most of the day. Following the investigation, the accused, identified as Kevin Stanley **ALFARO DIAZ**, was arrested.
