### Updates

**Aggravated Malicious Wounding \*UPDATE** – The Prince William County Police Department (PWCPD), in coordination with several federal, state, and local law enforcement agencies, executed approximately 14 search warrants in connection to the ongoing investigation into an altercation and shooting that was reported to have occurred at the Babylon Café located at 3081 Golansky Blvd in Woodbridge (22192) earlier this year on April 13. During the investigation, detectives determined the incident had affiliations tied to the Wheels of Soul motorcycle gang. The investigation revealed the victim, 42-year-old man, had been forcibly removed from the establishment to the parking lot by members of the gang where he was then assaulted, sustaining significant bodily injuries. After the assault, members of the gang remained congregated in the parking lot, when an acquaintance of the initial victim confronted the group, leading to exchange of gunfire resulting in over 80 rounds being fired. This morning, July 16, as part of the extensive investigation lead by PWCPD, a coordinated joint-operation was conducted by law enforcement authorities resulting in execution of multiple search warrants at addresses in the Woodbridge, Manassas, and Nokesville areas of Prince William County; locations in Stafford, Linden, Falls Church and the Hampton Roads area in Virginia; and two locations in Philadelphia, Pennsylvania. While conducting this operation, 19 individuals were either taken into custody or are actively being sought by law enforcement on outstanding charges related to this investigation. In total, 12 individuals were arrested while three additional suspects are still being sought. The information on those currently wanted individuals is not being released at this time. Four additional individuals were arrested on unrelated charges stemming from the activity today by law enforcement. This large-scale operation was conducted or assisted by hundreds of law enforcement professionals from the Federal Bureau of Investigation; the Bureau of Alcohol, Tobacco, Firearms, and Explosives; the U.S. Marshals Service; the Naval Criminal Investigative Service, the Drug Enforcement Administration; the U.S. Postal Inspection Service; the Virginia State Police; the Fairfax County Police Department; and the Philadelphia Police Department. **Aggravated Assault [Previously Released]** – On April 13 at 1:06AM, officers responded to Babylon Café located at 3081 Golansky Blvd in Woodbridge (22192) to investigate a shooting. The investigation revealed a fight had occurred in the parking lot resulting in shots being fired. Officers located a 42-year-old man with non-life threatening injuries sustained from the physical altercation. While on scene, a second man, 41-years-old, arrived at an area hospital with a non-life threatening gunshot wound to his arm. Both men were uncooperative with police regarding the suspect(s) involved and what led up to the altercation and subsequent shooting. Several vehicles and the business were struck by gunfire. No other injuries were reported. The suspect was described as a black male wearing a white t-shirt and operating a Harley-style motorcycle.
