Incidents

Shooting Investigation – On July 18 at 6:23PM, officers responded to the Dale Forest Apartments located in the 14400 block of Watson Ln. in Woodbridge (22193) to investigate a shots fired call. The investigation revealed there was an exchange of gunfire between two groups of individuals, all of whom left prior to police arriving at the scene. While investigating the incident, officers were informed that a 20-year-old man was brought to a local hospital with a non-life threatening gunshot wound to the leg. The man refused to cooperate with the investigation. Officers located shell casings on the ground near an electrical box and on the threshold of an apartment building. The entrance area of the apartment building sustained damage consistent with being struck by gunfire. No additional injuries or property damage were reported. The investigation continues as detectives determine the events that led up to the shooting and those involved.

Strangulation [Domestic] – On July 19 at 1:04AM, officers responded to a residence located in the 3000 block of James Madison Hwy. in Haymarket (20169) to investigate a domestic dispute. The investigation revealed the victim, a 24-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim and grabbed her neck before the parties eventually separated. The accused left the residence prior to police arriving at the home. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as William Lee **WARREN**. Attempts to locate the accused have been unsuccessful.

Commercial Burglary – On July 20 at 11:30AM, officers responded to Teresa Jewelry located at 13239 Occoquan Rd. in Woodbridge (22191) to investigate a burglary. The investigation revealed entry was forced into the business through the back door sometime between 8:00PM on July 19 and 11:00AM on July 20. Multiple watches were reported missing and additional damage was found to the interior of the store.

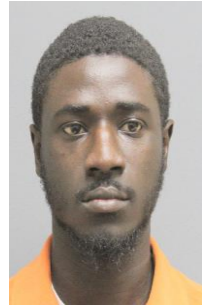

Arrests

Burglary With Intent to Assault – On July 17 at 9:58PM, officers responded to the Broadstone at River Oaks Apartments located in the 3100 block of Chesapeake Dr. in Dumfries (22026) to investigate a domestic related burglary. The investigation revealed the accused forced entry into the apartment of a 38-year-old female acquaintance while displaying an electronic restraint device. Once inside the apartment, the accused grabbed a pair of scissors and forced the victim into another room. The accused eventually left the apartment and returned a short time later, forcibly entering the apartment a second time and striking the victim. On July 20, the accused attempted to force entry into the residence again before leaving the area in a vehicle. When responding officers attempted to stop the vehicle, the accused failed to pull over and struck an unoccupied parked vehicle before driving out of the area. The accused then attempted flee on foot from the vehicle in the area of Blackburn Rd. and Richmond Hwy. before being detained without further incident. Further investigation revealed the accused did not have permission to drive the vehicle, had been previously trespassed from the apartment, and was in possession of suspected illegal drugs. No injuries were reported during any of the encounters. Following the investigation, officers obtained arrest warrants for the accused, identified as Lee Otis **TAYLOR**, who, on July 20, was located and arrested.

Assault & Battery on a Law Enforcement Officer [LEO] – On July 21 at 6:06AM, while officers were assisting with a separate incident, they were flagged down by personnel at Sentara Northern Virginia Medical Center located at 2300 Opitz Blvd. in Woodbridge (22191) for an individual fighting with staff members. Officers observed the individual, identified as the accused, actively assaulting security personnel and intervened. During the encounter, the accused struck hospital personnel and an officer before being detained without further incident. No injuries were reported. Following the investigation, the accused, identified as Dimitri Louis **WASHINGTON**, was arrested.



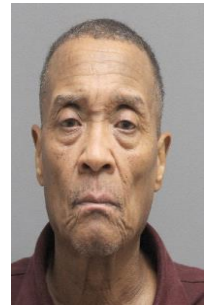

Assault & Battery on a Law Enforcement Officer [LEO] – On July 20 at 12:38AM, officers responded to a residence located in the 14400 block of General Washington Dr. in Woodbridge (22193) to investigate a domestic dispute. The investigation revealed the accused threw a food product striking a 69-year-old family member during an altercation. Officers detained the accused and while escorting him to a police vehicle, the accused actively resisted and kicked an officer before being re-secured without further incident. No injuries were reported. Following the investigation, the accused, identified as William Thomas **HUMPHRIES**, was arrested.
