Updates

Destruction of Property *UPDATE – On July 16, officers concluded the investigation into the attempted burglary that was reported to have occurred at a residence located in the 9800 block of Earls Ferry Cir in Bristow (20181) on July 12. Further investigation revealed, a juvenile followed a social media trend where he kicked the front door of the residence. The resulting action damaged the door. No intent to enter or steal from the property was determined. On July 16, following the investigation, officers sought petitions against the accused, identified as a **17-year-old male juvenile**, for destruction of property. After consultation with Juvenile Court Services, the case resulted in an informal action and will be handled through the juvenile diversion process.

Attempted Residential Burglary [Previously Released] – On July 12 at 9:32PM, officers responded to a residence located in the 9800 block of Earls Ferry Cir in Bristow (20181) to investigate an attempted burglary. The investigation revealed forced entry was attempted into the home through the front door which was found damaged. The homeowner was home at the time and immediately called the police. No entry was made into the home, and no property was reported missing. A police K-9 checked the area for the suspect who was not located. No suspect description was provided.

Malicious Wounding – On July 20 at 7:13PM, officers responded to the 13300 block of Occoquan Rd. in Woodbridge (22191) to investigate an assault. The investigation revealed the victim, a 39-year-old man, and a man whom the victim had previously encountered, were involved in an altercation in a wooded area near the above location. During the encounter, the suspect cut the victim with a machete-style knife. The suspect left the area prior to police arriving on scene. The victim was treated at an area hospital for non-life threatening injuries. The suspect was not located.

Suspect Description:

A Hispanic male, approximately 5'4", with a thin build

Last seen wearing blue shirt and pants, black shoes and possibly carrying a black backpack

Attempted Malicious Wounding – On July 17 at 2:37PM, officers responded to the Rimpal Inn located at 7399 Old Centreville Rd. in Manassas (20121) to investigate an assault. The investigation revealed the victim, a 66-year-old man, observed a physical altercation between a woman and a man in the room next door. When the victim attempted to intervene, the man, identified as the accused, struck him multiple times before the parties separated. Non-life threatening injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as James Roger **THOMAS**. Attempts to locate the accused have been unsuccessful.

Reckless Handling of a Firearm – On July 21 at 2:27PM, officers responded to the 14300 block of Gideon Dr. in Woodbridge (22192) to investigate a shots fired call. The investigation revealed two individuals were involved in an altercation over a firearm when a round was fired into the ground in a parking lot in the above area. All parties left prior to police arriving on scene. A shell casing was located in the parking lot. No injuries or property damage were reported.

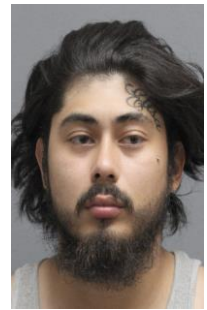

Reckless Handling of a Firearm – On July 20 at 10:08PM, officers responded to a residence located in the 11900 block of Parkgate Dr. in Nokesville (20181) to investigate a destruction of property. The investigation revealed sometime between 3:00PM and 4:00PM, multiple gunshots were heard in the area. Later that evening, the homeowner located damage to their home. No injuries or additional property damage were reported.

Reckless Handling of a Firearm – On July 19 at 5:47PM, officers responded to the area of Featherbed Ln. and General Trimbles Ln. in Manassas (20109) to investigate a destruction of property. The investigation revealed multiple gunshots were fired, striking a handicap parking sign in the parking lot near the above area. No injuries or additional property damage were reported.

Arrests

Felony Child Abuse – On July 17 at 12:03PM, officers responded to an area hospital to investigate a child abuse that was reported to have occurred at the Elevations One Apartments located in the 14300 block of Jeffries Rd. in Woodbridge (22191) on July 16. The investigation revealed the victim, a 4-month-old boy, had been transported to a local hospital after losing consciousness, where further examination revealed the child had sustained life-threatening injuries while in the care of his father, identified as the accused. On July 17, following the investigation, the accused, identified as Gianni **ROMERO-COREAS**, was arrested. On July 20, the victim's condition worsened, and he died later that day. The victim was transported to the Medical Examiner's Office for an autopsy to determine the cause and manner of death. Additional charges are pending. The investigation continues.
