**Malicious Wounding [Previously Released] -** On April 9 at 1:28PM, officers responded to investigate a domestic dispute that was reported to have occurred at the Regency Apartments located at the 9000 block of Gardenia Lane in Manassas (20109) on April 8 at approximately 10:30PM. The investigation revealed the victim, 41-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim in the head with a book multiple times before the parties separated. The victim was treated at an area hospital with non-life threatening injuries where the police were contacted. Following the investigation, officers obtained an arrest warrant for the accused, identified as Patrick Michael **Foreman.** Attempts to locate the accused have been unsuccessful.

**Strangulation [Domestic] -** On May 28 at 9:01PM, officers responded to a parking lot located in the 7700 block of Keara Ct. in Manassas (20109) to investigate a domestic dispute. The investigation revealed the victim, a 33-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused took the victim's phone before striking her and then grabbing her neck. Eventually, the victim was able to separate from the accused and exited the vehicle. The victim reported non-life threatening injuries. ### **Incidents**

**Fatal Crash Investigation** – On July 18 at 7:41PM, officers responded to the area of Four Seasons Dr. near Dumfries Rd. in Dumfries (22026) to investigate a crash. The investigation revealed the driver of a 2011 Toyota Highlander was traveling westbound on Four Seasons Dr. when the vehicle veered to the left leaving the roadway. The vehicle continued onto the median where it struck multiple trees before coming to rest. The driver, who was not wearing a seatbelt, is believed to have suffered a medical emergency and was transported to an area hospital, where she later died on July 20. No other occupants were in the vehicle.

**Armed Robbery** – On July 22 at 11:23AM, officers responded to the Woodbridge Station Apartments located in the 13600 block of Kitty Hawk Way in Woodbridge (22191) to investigate a robbery. The investigation revealed a food delivery driver was threatened and robbed by two unknown men, possibly teenagers. During the encounter, one of the suspects brandished a firearm from his waistband before the other suspect took the food. Both suspects left the area. The victim also left the area and reported the incident to the police. No injuries were reported. Officers searched the area for the suspects who were not located.

**Armed Robbery -** On July 21 at 8:14PM, officers responded to the Sunglass Hut inside Manassas Mall located at 8300 Sudley Rd. in Manassas (20109) to investigate a robbery. The investigation revealed an employee was assisting an unknown male patron inside the store when he began to grab pairs of sunglasses. When the employee attempted to confront the suspect, he implied he had a weapon and threatened the employee before leaving the store. No injuries were reported. The suspect was last seen exiting the mall and getting into a light-colored 4-door BMW sedan.
