### Updates

**Reckless Handling of a Firearm \*ARREST** – On July 24, the suspect sought in connection to the shooting that was reported to have occurred in the 14300 block of Gideon Dr. in Woodbridge (22192) on July 21, was arrested. During the investigation, officers identified the man who produced the firearm and fired a round during the altercation. On July 24, while in the area of Woonsocket Way and Telegraph Rd. officers located the suspect and, after a brief foot pursuit, he was detained. Officers also located a firearm discarded by the accused during the pursuit. Following the investigations, the accused, Jonathan Daniel **SMITH** was arrested.

**Reckless Handling of a Firearm [Previously Released]** – On July 21 at 2:27PM, officers responded to the 14300 block of Gideon Dr. in Woodbridge (22192) to investigate a shots fired call. The investigation revealed two individuals were involved in an altercation over a firearm when a round was fired into the ground in a parking lot in the above area. All parties left prior to police arriving on scene. A shell casing was located in the parking lot. No injuries or property damage were reported.

**Reckless Handling of a Firearm** – On July 25 at 12:35AM, officers responded to a residence located in the 2800 block of Gloucester Ct. in Woodbridge (22191) to investigate a shots fired call. The investigation revealed multiple rounds were fired striking two separate homes and four unoccupied vehicles. No injuries or additional property damage were reported. Shell casings were located in the intersection.

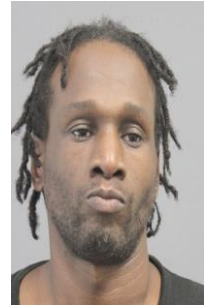

## Arrests

**Abduction [Domestic]** – On July 24 at 8:45PM, officers responded to investigate a domestic dispute that was reported to have occurred at a residence located in the 13500 block of Fitzhugh Ln. in Woodbridge (22191) on July 22. The investigation revealed the victim, a 41-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck and kicked the victim multiple times before the parties temporarily separated. The accused also prevented the victim from leaving the residence. At some point during the encounter, a 16-year-old male family member attempted to intervene, and the accused struck the juvenile before the victim was able to separate from the accused. The victims were eventually able to leave the residence and contacted the police. Both victims reported sustaining minor injuries during the incident. Further investigation revealed the accused also had an active protective order. Following the investigation, the accused, identified as Eric Lynn **MCNEIL**, was arrested.

**Strangulation [Domestic]** – On July 24 at 3:32AM, officers responded to the Rolling Brook Village Apartments located in the 1700 block of Pine Shadows Way in Woodbridge (22192) to investigate a domestic. The investigation revealed the victim, a 31-year old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim before grabbing her neck. The parties eventually separated, and the police were contacted. Non-life threatening injuries were reported. Following the investigation, the accused, identified as Tysean **HAMER**, was arrested.
