Felony Child Neglect *ARREST – On July 30, the suspect, identified as Alexandra Anna **GRANRUTH**, who was sought in connection to a child neglect investigation stemming from an incident that occurred in the 4000 block of Dawson Beach Rd. in Woodbridge (22191) on July 23, was arrested.

Felony Child Neglect [Previously Released] – On July 23 at 9:17PM, officers responded to a residence located in the 4000 block of Dawson Beach Rd. in Woodbridge (22191) for a found child. The investigation revealed the victim, a 2-year-old boy, was left unsupervised for an extended period of time by his mother, identified as the accused. Earlier that afternoon, at approximately 2:00PM, the accused contacted an acquaintance who located the victim in an unkempt state unaccompanied outside of the residence. The accused initially arranged for the care of the victim until later that evening. When the accused did not return to the area, the acquaintance contacted the police. When officers attempted to contact the accused, she refused to return to the area. The victim appeared uninjured and was turned over to known parties. Following the investigation, officers obtained arrest warrants for the accused, identified as Alexandra Anna **GRANRUTH.** Attempts to locate the accused have been unsuccessful.

Strong-Arm Robbery | Aggravated Assault - On July 30 at 3:02PM, officers responded to the area of

Silverdale Dr and Lindendale Rd in Woodbridge (22193) to investigate a robbery. The investigation revealed the victim, a 16-year-old male juvenile, was approached by three other male teenagers while he was riding

a scooter in the above area. During the encounter, the teens assaulted the victim and initially took his scooter before leaving it at the scene. The suspects left the area in a blue pickup truck. Minor injuries were

reported. The suspects were possibly known to the victim.

Commercial Burglary - On July 30 at 8:29AM, officers responded to the Elevations One Apartments leasing

office located at 1905 Stevens Rd in Woodbridge (22191) to investigate a burglary. The investigation revealed

sometime between 12:00AM and 12:45AM, entry was made into the office, possibly through an unsecured door. There were no signs of forced entry. Electronics and other items were reported missing.

Arrests

Malicious Wounding - On July 31 at 2:39AM, officers responded to a residence located in the 8100 block of

Spruce St in Manassas (20111) to investigate an assault. The investigation revealed the victim, 38-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated.

During the encounter, the accused retrieved a machete-style knife and threatened the victim. A struggle

over the weapon ensued, and the victim sustained a minor cut to her upper body. The parties separated

and the accused left the area before being detained later by Manassas Park police. Following the

investigation, the accused, identified as Layla Rae HUTCHESON, was arrested.
