Incidents

Fatal Crash Investigation – On July 13 at 2:09AM, officers responded to the area of Centreville Rd and Orchard Bridge Dr in Manassas (20111) to investigate a crash involving a pedestrian. The investigation revealed a 38-year-old woman was walking within the roadway along Centreville Rd when she was struck by a passing motorist driving a 2022 Honda Civic that was traveling south. At the time of the crash, the pedestrian was not in a designated crosswalk or safe crossing area. The driver of the Honda stayed at the scene and was not injured. The pedestrian was transported to an area hospital where she remained in critical condition until succumbing to her injuries from the collision on July 31. **Crash investigators are asking anyone who may have witnessed this crash to contact police.**

The pedestrian was identified as Carolina Isabel **Rosales Cepeda**, 38, of Manassas

The driver of the 2022 Honda Civic was identified as a **24-year-old woman** of Woodbridge

Death Investigation – On July 31 at 1:33PM, officers responded to the 4400 block of Cheshire Station Plz in Woodbridge (22193) to investigate a death. The investigation revealed a 26-year-old man was found unconscious in a bush near the above area. The man was pronounced dead on scene. Preliminarily, there were no signs of foul play. The body was transported to the Medical Examiner's Office for an autopsy to determine the cause and manner of death. At this time, there is no threat to the community concerning the death. More information regarding the investigation will be released if deemed necessary.

Attempted Malicious Wounding – On July 30 at 12:00AM, officers responded to the 13100 block of Tory Lp in Woodbridge (22192) to investigate an assault. The investigation revealed the victim, a 29-year-old woman, and another 25-year-old female friend were walking to a vehicle when a former male acquaintance of the victim, identified as the accused, attempted to strike both women with his vehicle. Both victims were able to move and avoid being struck. The accused then exited the vehicle and assaulted both women. The parties separated and police were contacted. No injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Devin Thomas **MCLEAN**. Attempts to locate the accused were unsuccessful.

Arrests

Murder Investigation – On July 31 at 5:42PM, officers responded to a residence located in the 12900 block of Kenmar Dr in Woodbridge (22193) to investigate a shooting. The investigation revealed the accused was involved in a verbal altercation with family members inside the home. At one point following the argument, the accused retrieved a firearm and shot two family members before calling emergency services. Officers arrived at the residence and detained the accused in front of the home without incident. While checking the residence, officers located a 42-year-old man and a 70-year-old woman, both suffering from gunshot wounds to the upper body. The male victim was pronounced dead on scene. Officers provided immediate first aid to the female victim who was transported to an area hospital where she remains in critical condition. A firearm was recovered at the home. Following the investigation, the accused, identified as Khampheng Toune **QUANLANGSY**, was arrested.

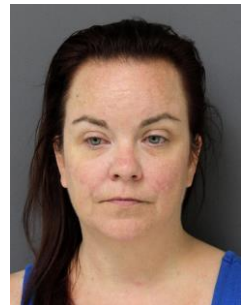

Strangulation [Domestic] – On July 31 at 1:21AM, officers responded to a residence located in the 3100 block of Tecumseh Ct in Woodbridge (22192) to investigate a domestic dispute. The investigation revealed the victim, a 23-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, a physical altercation ensued in which the accused got on top of the victim and grabbed her neck. The parties separated and police were contacted. Minor injuries were reported. Following the investigation, the accused, identified as Angela Renee **FRANKLIN**, was arrested.

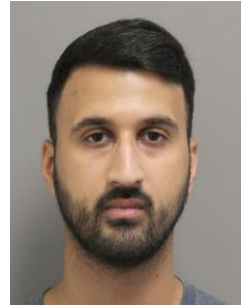

Abduction [Domestic] – On July 31 at 8:48AM, officers responded to a residence located in the 16500 block of Telescope Ln in Dumfries (22026) to investigate a domestic dispute. The investigation revealed the victim, a 30-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused blocked the victim from leaving before taking her phone away as she attempted to contact emergency services. The accused then forcibly grabbed the victim and dragged her to another room where he threw her to the ground. The parties separated and police were contacted. Minor injuries were reported. Following the investigation, the accused, identified as Rizwan Badrul **ISLAM**, was arrested.

Aggravated Assault | Conspiracy to Commit Felony – On July 31 at 10:24PM, officers responded to the 1400 block of Illinois Ct in Woodbridge (22191) to investigate a fight. The investigation revealed the victim, a 16-year-old female juvenile, was visited by a female juvenile acquaintance, identified as the accused, and two other unknown female juveniles. During the encounter, the two unknown juveniles assaulted the victim. The parties separated and police were contacted. The victim was treated at an area hospital for non-life threatening injuries. Officers determined the accused conspired with the other juveniles to assault the victim. Following the investigation, the accused, identified as a **15-year-old female juvenile**, was arrested. The two other assailants were not immediately identified and are still being sought.

Attempted Malicious Wounding [Domestic] | Assault & Battery on a Law Enforcement Officer [LEO] –

On July 31 at 10:19PM, officers responded to the Bayvue Apartments located in the 1400 block of Bayside Ave in Woodbridge (22191) to investigate a domestic. The investigation revealed the accused entered the room of a 31-year-old male family member and assaulted him. The parties separated and a parent of the accused, identified as a 35-year-old man, came to the residence where the accused then retrieved a knife and chased him. The parties separated and police were contacted. Following the investigation, the accused, a **17-year-old male juvenile**, was arrested. While in custody, the accused became uncooperative and kicked an officer. No injuries were reported by any parties involved.

Assault & Battery on a Law Enforcement Officer [LEO] | Indecent Exposure – On July 31 at 7:39AM, officers responded to the 14700 block of Candlewood Ct in Woodbridge (22191) to investigate an indecent exposure. The investigation revealed a woman, later identified as the accused, was walking along the sidewalk unclothed. When officers attempted contact with the accused, she began to walk away. As officers then attempted to detain the accused, she fled on foot and a struggle ensued during which she struck an officer multiple times to their head. No injuries were reported. Following the investigation, the accused, identified as Susan Yohannes **TEWOLDE**, was arrested.
