**Strangulation [Domestic] [Previously Released] -** On July 19 at 1:04AM, officers responded to a residence located in the 3000 block of James Madison Hwy. in Haymarket (20169) to investigate a domestic dispute. The investigation revealed the victim, a 24-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim and grabbed her neck before the parties eventually separated. The accused left the residence prior to police arriving at the home. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as William Lee **WARREN.** Attempts to locate the accused have been unsuccessful.

**Strangulation [Domestic] [Previously Released] -** On July 8 at 4:39PM, officers responded to investigate a domestic dispute that was reported to have occurred in the 8300 block of Sudley Rd. in Manassas (20109) in May 2025. The investigation revealed the victim, a 21-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused struck the victim before grabbing her neck multiple times. The parties eventually separated. While investigating the incident, officers determined there was an additional incident in May where the accused grabbed the victim's neck. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Juan Miguel **GARCIA ANDRADE**. Attempts to locate the accused have been unsuccessful.

**Attempted Malicious Wounding [Previously Released]** – On July 30 at 12:00AM, officers responded to the 13100 block of Tory Lp in Woodbridge (22192) to investigate an assault. The investigation revealed the victim, a 29-year-old woman, and another 25-year-old female friend were walking to a vehicle when a former male acquaintance of the victim, identified as the accused, attempted to strike both women with his vehicle. Both victims were able to move and avoid being struck. The accused then exited the vehicle and assaulted both women. The parties separated and police were contacted. No injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Devin Thomas **MCLEAN**. Attempts to locate the accused were unsuccessful.

**Malicious Wounding [Domestic] -** On August 1 at 9:38PM, officers responded to Glen Ridge Commons Apartments located in the 12800 block of Island House Lp. in Woodbridge (22193) to investigate a domestic dispute. The investigation revealed the victim, a 37-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated while in a parked vehicle. During the encounter, the accused grabbed the victim around the neck and dragged her out of the vehicle before kneeling and pinning her to the ground. Eventually the parties separated, and the victim left the parking lot. The accused damaged the victim's vehicle and left the area prior to police
