Incidents

Shooting Investigation | Residential Burglary – On August 6 at 9:38PM, officers responded to a residence located in the 3600 block of Tavern Way in Triangle (22172) to investigate a shooting. The investigation revealed two men attempted to forcibly enter the residence when shots were fired. Parties dispersed prior to officers arriving in the area. During the investigation, an adult male showed up at an area hospital suffering from non-life threatening gunshot wounds. The man was uncooperative with officers. The incident was not random and is believed to have stemmed from a drug deal over marijuana.

Arrests

Sexual Assault Investigation – On July 31, detectives concluded an investigation into a sexual assault that was reported to have occurred in the Woodbridge (22193) area of Prince William County between January 2019 and March 2021. The investigation revealed the victim, who was under the age of 10 at the time of the offenses, was sexually assaulted on more than one occasion during the above timeframe by a known individual, identified as the accused. The victim recently reported the incidents prompting the police investigation. Following the investigation, detectives obtained arrest warrants for the accused. On July 31, the accused, identified as Gabriel **BENITEZ VASQUEZ**, was arrested in Fort Myer.



Attempted Malicious Wounding [Domestic] – On August 6 at 7:24PM, officers responded to the 3600 block of Lions Field Rd in Triangle (22172) to investigate a domestic-related incident. The investigation revealed the victim, a 53-year-old man, was arriving at his home when he encountered an acquaintance, identified the accused. The victim attempted to drive away from the accused who followed the victim in a separate vehicle. At one point, the victim encountered the accused in the above area where she then crossed into his lane, almost striking his vehicle head on. The victim ran off the



roadway to avoid the collision and damaged his vehicle. No injuries were reported. The accused was located and detained without incident. Following the investigation, the accused, identified as Clarissa **WILSON**, was arrested.
