Updates

Residential Burglary *ARREST – On August 28, 2025, officers arrested a suspect, identified as Ceasar **AMAYA**, in connection to the burglary that was reported to have occurred at a residence located in the 4200 block of Potomac Highlands Cl. in Triangle (22172) on October 17, 2024.

Attempted Residential Burglary [Previously Released] – On October 17 at 8:20AM, officers responded to a residence located in the 4200 block of Potomac Highlands Cl. in Triangle (22172) to investigate a burglary that occurred earlier that morning. The investigation revealed between 2:00AM-2:30AM, the homeowners woke to a loud noise. Upon checking the home, an unknown individual was observed through the open bedroom window leaving the area. Officers determined no entry was made into the residence and no property was reported missing.

Incidents

Death Investigation - On August 31 at 2:01AM, officers responded to a residence located in the 16100 block of Edgewood Dr in Dumfries (22025) to investigate a death. The investigation revealed a 61-year-old man was found unconscious inside a vehicle parked in the driveway of the home. The man was pronounced dead on scene. Preliminarily, there were no signs of foul play. At this time, there is no threat to the community concerning the death. More information regarding the investigation will be released if deemed necessary.

Armed Robbery – On August 31 at 2:35 AM, officers responded to the 7-Eleven located at 18750 Fuller Heights Rd in Triangle (22172) to investigate a robbery. The investigation revealed the victim, a 27-year-old man, was pumping gas when he was approached by an unknown masked man. During the encounter, the man brandished a firearm and took the victim's property before leaving the area on foot. No injuries were reported. A K-9 and Fairfax police helicopter searched the area for the suspect who was not located. The masked suspect was wearing a mask, dark-colored sweater or wind breaker, and dark-colored pants.

Attempted Armed Robbery - On September 1 at 10:55PM, officers responded to the Haven Woodbridge apartments located at in the 13900 block of Longwood Manor Ct in Woodbridge (22191) to investigate an attempted robbery. The investigation revealed the victim, a 41-year-old man, was in the breezeway of the building when he was approached by two unknown masked men. During the encounter, the men brandished firearms and demanded the victim's property. The suspects left on foot when another person approached. No injuries were reported, and no property was taken. A K-9 searched the area for the suspects who were not located. The masked suspects were only described as black males wearing dark-colored clothing.

Reckless Handling of a Firearm – On September 1, officers responded to investigate shots fired call that was reported to have occurred in the parking lot of Ninety Degrees located at 8509 Rixlew Ln in Manassas (20109) earlier that morning around 1:00AM. The investigation reaved a physical altercation had occurred in the parking lot before the parties separated. One of the parties returned a short time later and gunshots were heard. The nearby Word Alive Church International was struck. No injuries or other property damage were reported. The parties involved in the altercation were known to one another.

Reckless Handling of a Firearm – On August 30 at 5:36PM, officers responded to the area of Graham Park Rd and Old Triangle Rd in Triangle (22172) to investigate a shots fired call. The investigation reaved several gunshots were exchanged between multiple individuals in the above area before all parties dispersed. Two homes on nearby Heth Ct were struck. No injuries or other property damage were reported. Suspects involved were described as black males in their late teens-late 20s/early 30s.

Reckless Handling of a Firearm – On August 28 at 9:10PM, officers responded to the 14300 block of Jeffries Rd in Woodbridge (22191) to investigate a shots fired call. The investigation revealed the two men were reportedly involved in a physical altercation in a parking lot in the above area. When the parties separated, a woman with one of the men fired a round. The parties dispersed prior to police arriving on scene. During the investigation, the woman and one of the men involved the alleged victim, were identified. The victim was not cooperative with the investigation. No injuries or property damage were reported. A shell casing and an unspent round were located on a sidewalk.

Residential Burglary | Assault - On September 1 at 7:28PM, officers responded to a residence located in the 8300 block of Cobb Rd in Manassas (20112) to investigate a burglary. The investigation revealed the homeowner, a 62-year-old woman, was confronted by an unknown man who had entered the residence without permission. At the time of the incident, the homeowner was renovating the residence and had left the front door open. The man engaged the victim in conversation before proceeding to hug and kiss her without consent. The suspect then left the home. No injuries were reported, and no property was taken. The suspect was last seen getting into a red van with a thunderbolt along the side.

Hispanic male, later 30s/early 40s, 6'4" with a thin build, black hair and a scraggly beard No clothing description reported

Attempted Commercial Burglary – On September 1 at 4:30AM, officers responded to the Cabelas located at 5291 Wellington Branch Dr in Gainesville (20155) to investigate an attempted burglary. The investigation revealed overnight staff inside the business observed three unknown individuals attempt to enter the business by shattering the front glass windows with a blunt object before leaving the area. No entry was made into the business, and no property was reported missing. The suspects were only described as wearing all dark-colored clothing.

Attempted Residential Burglary – On August 29 at 7:57PM, officers responded to investigate an attempted burglary that was reported to have occurred at a residence located in the 4900 block of Brightleaf Ct in Woodbridge (22193) earlier that afternoon around 2:00PM. The investigation revealed two unknown individuals had attempted to enter through a basement door. No entry was made into the home, and no property was reported missing. The suspects were only described as two tall white males.

Aggravated Sexual Battery | Indecent Liberties - On August 29, the Internet Crimes Against Children (ICAC) Task Force executed a search warrant at a residence located in the 15000 block of Greenmount Dr in Woodbridge (22193) in connection to an ongoing investigation into inappropriate child material that began in January 2025. The investigation resulted from an ICAC cyber-tip regarding images that were later connected to a resident at the home, identified as the accused. During the investigation, a separate assault case was reported to police connecting the accused to incidents that



occurred in 2020 involving a victim who was under the age of 13 that had been sexually assaulted on more than one occasion. Following both investigations, the accused, identified as Amir-Arsolan Binaie **KONDOLOJY**, was arrested.

Aggravated Malicious Wounding – On August 30 at 1:20AM, officers responded to Bar Louie located at 14081 Promenade Commons St in Gainesville (20155) to investigate a shooting. The investigation revealed the victim, a 26-year-old man, was involved in a verbal altercation with another a juvenile male, later identified as the accused, inside the restaurant. The altercation escalated and shots were fired by the accused, before the parties dispersed. The victim sustained a gunshot wound to the lower body and was treated at an area hospital where the injury was determined to be non-life threatening. While investigating the incident, the suspect arrived at a separate hospital with a non-life threatening gunshot wound to the lower body, preliminarily believed to have been inadvertently self-inflicted after the earlier altercation. Following the investigation, the accused, identified as a **17-year-old male juvenile**, was arrested.

Malicious Wounding – On August 31 at 7:59PM, officers responded to the 13500 block of Spriggs Rd in Manassas (20112) to investigate an assault. The investigation revealed the victims, a 62-year-old man and a 44-year-old woman, were walking in the above area when they were approached by an unknown woman, later identified as the accused. During an unprovoked encounter, the accused knocked the female victim to the ground and then bit the male victim who attempted to intervene in the assault. The accused then left the area on foot. Both victims were treated at an area hospital for




non-life threatening injuries. The suspect was later located at her home and detained. Following the investigation, the accused, identified as Quai Alexandria **TRAVIS**, was arrested.

During the investigation, one of the parties involved, identified as the accused, attempted to leave the home. While attempting to detain the accused, she resisted leading to a physical altercation where she kicked and bit an officer. The accused was eventually detained. Minor injuries were reported. Following the investigation, the accused, identified as Yanin **FLORES GODOY**, was arrested.

Assault & Battery on a Law Enforcement Officer [LEO] – On August 30 at 4:43PM, officers responded to the Walmart located at 9401 Liberia Ave in Manassas (20110) to investigate a shoplifting. Officers arrived on scene and located the accused nearby. While attempting to detain the accused, she resisted leading to a physical altercation where she scratched an officer in their face. The accused was eventually detained. Minor injuries were reported. The investigation into the shoplifting revealed the accused attempted to leave the store wearing unpaid clothing. When confronted by



store staff, she removed the clothing, exposing herself. Following the investigation, the accused, identified as Monica Patricia **ANDRADE**, was arrested.
