### Updates

**Carjacking [Domestic] \*ARREST** – On September 1, officers arrested the suspect, identified as Peshwaz Azad **WAISE**, who was sought in connection to a domestic-related carjacking that was reported to have occurred in the 9400 block of Liberia Ave in Manassas (20110) on July 2.

**Carjacking [Domestic] [Previously Released]** – On July 2 at 8:17PM, officers responded to the 9400 block of Liberia Ave. in Manassas (20110) to investigate a carjacking. The investigation revealed the victim, a 63-year-old woman, and a family member, identified as the accused, were involved in a verbal altercation that escalated inside a vehicle. During the encounter, the accused forcefully grabbed the keys and then pulled the victim out of the vehicle before driving away in the vehicle. Minor injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as Peshwaz Azad **WAISE**. Attempts to locate the accused have been unsuccessful.

**Attempted Malicious Wounding \*ARREST** – On September 2, the suspect who was sought in connection to an assault that was reported to have occurred in the 7300 block of Old Centreville Rd in Manassas (20111) on July 17, was arrested. The accused, identified as James Roger **THOMAS Jr.**, was taken into custody by Manassas City police.

**Attempted Malicious Wounding [Previously Released]** – On July 17 at 2:37PM, officers responded to the Rimpal Inn located at 7399 Old Centreville Rd. in Manassas (20111) to investigate an assault. The investigation revealed the victim, a 66-year-old man, observed a physical altercation between a woman and a man in the room next door. When the victim attempted to intervene, the man, identified as the accused, struck him multiple times before the parties separated. Non-life threatening injuries were reported. Following the investigation, officers obtained arrest warrants for the accused, identified as James Roger **THOMAS**. Attempts to locate the accused have been unsuccessful.

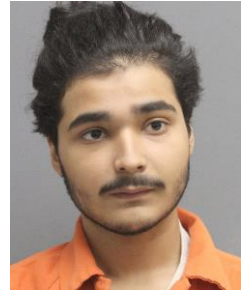
**Possession of Firearm by a Convicted Felon \*ARREST** – On August 28, officers arrested a suspect, identified as Cris Alonzon **SORIANO-MORALES**, in connection to the reckless handling of a firearm incident that occurred in the area of Apache Ridge and Halterpath Trl. in Manassas (20109) on July 5.

**Reckless Handling of a Firearm [Previously Released]** – On July 5 at 6:42PM, officers responded to the area of Apache Ridge and Halterpath Trl. in Manassas (20109) to investigate a shots fired call. The investigation revealed a home on Apache Ridge and a vehicle occupied by a 19-year-old man were struck during an exchange of gunfire. Officers located the vehicle and determined rounds were fired towards the vehicle and from within the vehicle. Officers also located shell casings in the grassy area of Apache Ridge and Halterpath Trl. No injuries or additional property damage were reported.

## Incidents

**Aggravated Assault | Strong-Arm Robbery** – On August 29, officers continued an investigation which was initially believed to be a hit & run crash that was reported to have occurred in the 13900 block of Richmond Hwy in Woodbridge (22191) on August 21 at 2:40AM. The ongoing investigation in the incident revealed the victim, a 20-year-old man, was sitting inside a vehicle in the parking lot of the nearby Ricos Tacos Moya when two men and two women approached. During the encounter, the one of the men assaulted the victim as he sat in the vehicle. At one point, the victim was pulled from the vehicle where the assault continued and the victim lost consciousness. The parties separated and the assailant left the area in a dark-colored SUV with the other parties. The victim regained consciousness and was later located by officers in a grassy median along Richmond Hwy where it was initially believed the victim had been struck by a passing motorist. The victim reported property was missing that had not been located at the scene. No further suspect description for the assailant is available at this time.

**Reckless Handling of a Firearm** – On September 2, officers responded to investigate a shots fired call that was reported to have occurred in the 3100 block of Chesapeake Dr in Dumfries (22026) on August 30 between 1:30PM and 4:00PM. The investigation revealed that sometime during the listed timeframe, a vehicle had been struck by gunfire. Shell casings were also located nearby. The vehicle's owner notified security of the incident at the time. A witness also reported to security that the suspect was a black male with a thin build wearing dark-colored clothing. Police were not immediately contacted.

**Indecent Exposure** – On September 2 at 11:52AM, officers responded to Wegmans located at 14801 Dining Way in Woodbridge (22191) to investigate an indecent exposure. The investigation revealed the victims, two 18-year-old women, were sitting at a table on the second-floor dining area when they observed an unknown man sitting nearby. During the encounter, the victims observed the man had exposed himself and was making inappropriate gestures. The man eventually left the store. No physical or verbal contact occurred between the man and the victims. Officers checked the area for the suspect who was not located.

***Suspect Description:***

Black male, unknown age, 5'7"-5'9" with a muscular build, black hair and a full beard

Last seen wearing a black Nike hat, gray shorts, white shoes, black T-shirt, headphones, a phone armband, and carrying a black backpack

## Arrests

**Assault & Battery on Law Enforcement Officer [LEO]** – On September 2 at 7:50AM, the School Resource Officer [SRO] assigned to Potomac High School located at 3401 Panther Pride Dr in Dumfries (22026) was notified a student actively assaulting school staff. When the SRO intervened, the student, identified as a **17-year-old female juvenile**, assaulted and attempted to run from the officer. The student was quickly apprehended. During the arrest, the student kicked school security staff and the SRO, including biting and spitting on them. Minor injuries were reported. Following the investigation, the student was arrested.
