Armed Robbery | Abduction *ARREST – On August 27, a suspect, identified as Darnell **MARSHALL**, was arrested in connection to a shooting that was reported to have occurred in the 3600 block of Tavern Way in Triangle (22172) on August 6. Detectives are still seeking a second suspect involved.

Shooting Investigation | Residential Burglary [Previously Released] – On August 6 at 9:38PM, officers responded to a residence located in the 3600 block of Tavern Way in Triangle (22172) to investigate a shooting. The investigation revealed two men attempted to forcibly enter the residence when shots were fired. Parties dispersed prior to officers arriving in the area. During the investigation, an adult male showed up at an area hospital suffering from non-life threatening gunshot wounds. The man was uncooperative with officers. The incident was not random and is believed to have stemmed from a drug deal over marijuana.

Strangulation *ARREST – On September 7, the suspect, identified as Andre Jordan **WOODING**, who was sought in connection to an assault that was reported to have occurred in the 1200 block of Bayside Ave. in Woodbridge (22191) on May 19, was arrested.

Strangulation [Previously Released] – On May 19 at 9:10PM, officers responded to the Bayvue Apartments located in the 1200 block of Bayside Ave. in Woodbridge (22191) to investigate an assault. The investigation revealed the victim, a 34-year-old woman, and an acquaintance, identified as the accused, were involved in a verbal altercation that escalated. During the encounter, the accused pushed the victim and smashed a bathroom vanity before grabbing the victim's neck. Eventually, the victim was able to temporarily separate from the accused before he threw a knife, striking her in the hand. The accused left the apartment complex prior to police arriving in the area. The victim reported non-life threatening injuries. Following the investigation, officers obtained arrest warrants for the accused, identified as Andre Jordan **WOODING**. Attempts to locate the accused have been unsuccessful.

Aggravated Assault – On September 7 at 12:54AM, officers responded to the 2600 block of the Prince William Pkwy in Woodbridge (22192) to investigate an assault. The investigation revealed the victim, a 23-year-old man, and an unknown man were involved in a verbal altercation that escalated. During the encounter, the suspect struck the victim on the back of the head with a flashlight. The victim lost consciousness, and the suspect left the area. The victim was treated at an are hospital for non-life threatening injuries. The suspect was not located and was only described as a black male.

Reckless Handling of a Firearm – On September 5 at 9:49AM, officers responded to a residence located in the 2500 block of Grayton Ln in Woodbridge (22191) to investigate a destruction of property. The investigation revealed a bullet hole was found in a kitchen window and another hole in the upper floor sliding. No injuries or other property damage were reported. The timeframe of the damage is unknown.

Attempted Residential Burglary – On September 7 at 1:19AM, officers responded to a residence located in the 4700 block of Kentwood Ln in Woodbridge (22193) to investigate an attempted burglary. The investigation revealed an unknown individual was seen attempting to enter the residence through basement level sliding glass door. No entry was made into the home, and no property was reported missing. The suspect was last seen leaving the area on foot and was only described as being around 5'8"-5'9" with a thin build wearing a dark-colored hooded sweatshirt

Arrests

Sexual Assault Investigation – On September 5 at 8:44PM, officers responded to Paramount Senior Living located at 8341 Barrett Dr in Manassas (20109) to investigate an assault. The investigation revealed staff members at the facility had located an unknown man, later identified as the accused, in the room of an 89-year-old female resident. The accused was not known to the victim resident and was reportedly at the facility visiting other family members who reside at the same location. Detectives determined the accused had sexually assaulted the victim before being discovered by staff. The accused left the location and was located and detained nearby by officers. The victim was treated at an area hospital. Following the investigation, the accused, identified as Harold Leon **EDWARDS II**, was arrested.

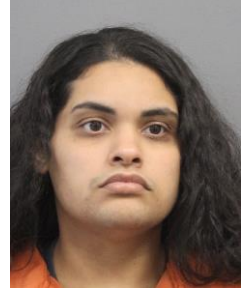

Attempted Malicious Wounding of a Law Enforcement Officer [LEO] – On September 7 at 8:18PM, officers responded to the 14200 block of Clatterbuck Lp in Gainesville (20155) to investigate a domestic dispute occurring in a vehicle. During the investigation, officers attempted contact with one of the parties involved, identified as the accused, who was in the driver's seat of the vehicle. At one point, the accused quickly reversed the vehicle, nearly striking the officer. The accused stopped the vehicle and attempted to flee on foot before being detained. No injuries were reported. Following the investigation, the accused, identified as Milagros Alisha **MENDEZ**, was arrested.

Strong-Arm Robbery – On September 6 at 11:42AM, officers responded to Gabes located at 8313 Sudley Rd in Manassas (20109) to investigate a shoplifting. The investigation revealed the store manager attempted to stop an unknown man, later identified as the accused, for concealing merchandise and attempting to leave the business. During the encounter, a physical struggle ensued before the accused left the area with the items. Officers were able to identify the accused and obtain an arrest warrant. The accused, identified as Brandon Darnel **HILL**, was later arrested that evening.
