**Aggravated Malicious Wounding \*ARREST –** On September 10, 2025, the suspect sought in connection to multiple shooting incidents that were reported to have occurred in the Woodbridge (22191) area of Prince William County on November 15, 2024 and May 2, 2025, was arrested. The accused, identified as Taylohn Jashaud **ANDREWS**, was taken into custody in Stafford County by the U.S. Marshals Fugitive Task Force.

Charged with aggravated malicious wounding, use of a firearm in commission of a felony, shooting into a residential dwelling, and reckless handling of a firearm

Shooting Investigation \*ADDITIONAL INCIDENT [Previously Released] - On May 2 at 10:28PM, officers responded to the Woodbridge Station Apartments located in the 1500 block of Ranger Loop in Woodbridge (22191) to investigate a shooting. The investigation revealed a man, later identified as the accused, was handling a firearm when a round was discharged. The round entered the apartment below through the ceiling before lodging into the kitchen floor of the apartment. The accused left the apartment prior to police arriving at the scene. No injuries or additional property damage were reported. Following the investigation, officers obtained arrest warrants for the accused identified as Taylohn Jashaud ANDREWS. Officers also determined ANDREWS has additional active arrest warrants for a shooting incident that was reported to have occurred in Woodbridge on November 15, 2024. Attempts to locate the accused have been unsuccessful.

**Aggravated Malicious Wounding [Previously Released] –** Detectives are seeking the suspect sought in the shooting that was reported to have occurred at the Summerhouse II Condos located in the 1000 block of Gardenview Lp in Woodbridge (22191) on November 15. Detectives identified and obtained arrest warrants for the suspect, identified as Taylohn Jashaud **ANDREWS**. Attempts to locate the accused were unsuccessful.

**Shooting Investigation [Previously Released] –** On November 15 at 1:39AM, officers responded to the Summerhouse II Condos located in the 1000 block of Gardenview Lp in Woodbridge (22191) to investigate a shooting. The investigation revealed an 18-year-old man was shot in the lower body and found by responding officers next to a vehicle in the parking lot. The man was treated at an area hospital where the injury was determined to be non-life threatening. The altercation is believed to have occurred in a nearby residence where a shell casing and marijuana were located. The man was not forthcoming with investigators as to what led up to the shooting or the other parties involved. **This incident is not believed to be random.** 

#### **Incidents**

**Indecent Exposure** – On September 10 at 8:19AM, officers responded to the area of Old Kings Rd and Old Post Ter in Woodbridge (22191) to investigate an indecent exposure. The investigation revealed the victim, a 27-year-old woman, was walking in the above area when she observed an unknown individual, believed to be a male in his teens, sitting on a bench. At one point, the male exposed himself and made inappropriate gestures before walking into a nearby wooded area. No verbal or physical contact occurred between the two parties. Officers checked the area for the suspect who was not located.

White male, late tens with a thin build Last seen wearing a camouflage hooded sweatshirt, dark-colored sweatpants, black and white shoes, and carrying a dark-colored backpack
