Updates

Murder Investigation *ARRESTS – Prince William County detectives have charged two men in connection to the murder of a 35-year-old man that occurred in the 13700 block of Telegraph Rd. in Woodbridge (22192) on September 13. The investigation revealed the two suspects were previously involved in a physical altercation with the deceased. When the parties separated, the victim attempted to walk away and was shot. A second man was nearby during the altercation and inadvertently shot. During the investigation, detectives were able to identify both suspects and obtain arrest warrants. One of the men, identified as Jordy **LOPEZ CAMPOS**, was taken into custody on September 16 at a home on Culpeper Dr in Woodbridge. The second suspect, identified as David Omar **BENITEZ MARTINEZ**, was located and arrested on September 19 at a home on Hampstead Ridge Ct in Dumfries. Narcotics and multiple firearms were recovered during the arrests.

Murder Investigation [Previously Released] - On September 13 at 7:00PM, officers responded to the 13700 block of Telegraph Rd. in Woodbridge (22192) to investigate a shooting. When officers arrived in the above area, officers located one adult male suffering from a gunshot wound. Fire and rescue personnel responded and pronounced the 35-year-old victim deceased at the scene. A second victim, a 27-year-old man, ran from the scene and was located at a nearby restaurant. The second victim was transported to an area hospital with non-life-threatening injuries. The initial investigation revealed the 35-year-old victim was in the above area and was in an argument with two unknown males prior to the shooting. **Detectives are asking anyone with any information, or who may have witnessed this incident, to please contact police. This incident does not appear random.** The investigation continues.

Incidents

Brandishing of a Firearm – On September 21 at 10:09PM, officers responded to the area of I-66 and Lee Hwy in Gainesville (20155) to investigate a road rage. The investigation revealed the victims, a 36-year-old woman and a 35-year-old man, were driving in the above area when they encountered another driver in an older model, red & silver square body GMC truck. While the vehicle was traveling behind the victims, a gunshot was reportedly heard. No injuries were reported, and no evidence of shots being fired was located. The other driver, described as a black male with short hair and a beard, was not located.

Reckless Handling of a Firearm – On September 20 at 11:22PM, officers responded to a residence located in the 10000 block of Brandon Way in Manassas (20109) to investigate a shots fired call. The investigation revealed several gunshots were fired which struck the home. Officers located multiple shell casings in the area. No injuries or other property damage were reported. **This incident does not appear to be random.**

Residential Burglary – On September 22 at 4:03AM, officers responded to the Ravens Crest apartments located in the 8100 block of Weatherwood Ct in Manassas (20109) to investigate a burglary. The investigation revealed an unknown man had entered an apartment through the sliding glass door. The man immediately left the home when confronted by a resident. There were no signs of forced entry into the apartment, and no property was reported missing.

Hispanic male, early 20s, 5'8", 100lbs, bald with a beard Last seen wearing a long-sleeved checkered green shirt and blue jeans

Arrests

Malicious Wounding - On September 21 at 2:49AM, officers responded to the 7200 block of Centreville Rd in Manassas (20111) to investigate a fight. The investigation revealed the victim, a 49-year-old man, was approached by an unknown man, later identified as the accused, in a parking lot in the above area. During the encounter, the accused struck the victim in the face, causing a significant injury. A second who attempted to intervene was also struck by the accused. The parties eventually separated, and police were contacted. The initial victim was treated at an area hospital



for non-life threatening injuries. Following the investigation, the accused, identified as Juan Ramon **CHAVEZ GALICIA**, was arrested.

Brandishing of a Firearm – On September 22, officers concluded an investigation into a brandishing that was reported to have occurred in the 5500 block of Blasius Ct in Woodbridge (22193) on September 10 at approximately 6:00PM. The investigation revealed the victims, a 17-year-old male juvenile and a 16-year-old male juvenile, were inside a vehicle parked in the above area when they were approached by another vehicle operated by an unknown man, later identified as the accused. During the encounter, a verbal altercation ensued before the accused reportedly brandished a firearm. No injuries were reported, and no shots were fired. The parties separated and the incident was reported to police the following day. Following the investigation, the accused, identified as Bradley Hunter **CARICOFE**, was charged.

Assault & Battery on a Law Enforcement Officer [LEO] – On September 19 at 5:03PM, officers responded to Target located at 9900 Sowder Village Sq in Manassas (20109) to investigate a shoplifting. During the investigation, officers attempted to detain the accused who fled on foot before being taken into custody. While being detained, the accused struck an officer in the face. No injuries were reported. While in custody, the accuse initially provided a false identity to the officer and was found in possession of suspected illicit narcotics. Following the investigation, the accused, identified as Corinne Kay ABOUREZK MACIAS, was arrested.
