Incidents

Fatal Crash Investigation – On October 12 at 4:45AM, officers responded to the area of Prince William Parkway and Hansen Farm Rd in Manassas (20109) to investigate a crash. The investigation revealed the driver of a 2022 Mack Anthem truck, identified as a 35-year-old man, was traveling east on Prince William Parkway approaching the intersection of Hansen Farm Road. The truck veered off the roadway, onto the right shoulder and struck a guardrail, before coming to rest a short distance later. The driver was transported to an area hospital and was later pronounced deceased. At this time, it is believed the driver of the Mack truck may have suffered a medical emergency prior to the crash. **Crash investigators are asking anyone who may have witnessed this crash to contact police.**

Armed Robbery – On October 10, officers responded to investigate a robbery that was reported to have occurred at the Exxon located at 4255 Seeton Sq in Woodbridge (22192) on October 9 at approximately 10:00PM. The investigation revealed two men approached an employee at the counter and demanded merchandise before leaving the store on foot. One of the men brandished a firearm during the encounter. No injuries were reported.

Suspect Descriptions:

Black male, between 18 & 25 years old with a muscular build, black hair, and brown eyes
Last seen wearing sunglasses, a black tank top, grey sweatpants, and black shoes

Black male, between 16 & 25 years old, 5'8" with a small build and short deadlocks
Last seen wearing a black ski mask, dark gray hooded sweatshirt, black sweatpants, black crocs, and carrying a black backpack

Aggravated Assault – On October 11 at 7:40AM, officers responded to Andrew Leitch Park located at 5301 Dale Blvd in Woodbridge (22193) to investigate an assault. The investigation revealed the victim, a 47-year-old woman, was at the park when she was approached by an unknown individual who reportedly grabbed the victim before striking her with an unknown object. A family member arrived at the park and found the victim alone on the ground with injuries. The assailant was not seen by the victim and was not located by responding officers and a police K-9 after a search of the area.

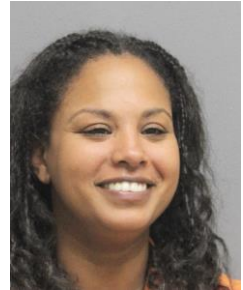

Arrests

Assault & Battery on a Law Enforcement Officer [LEO] – On October 11 at 9:36PM, officers responded to the Landing at Mason's Bridge Apartments located in the 13100 block of Masons Bridge Rd in Woodbridge (22192) to investigate a burglary. The investigation revealed an unknown woman, later identified as the accused, appeared intoxicated and had entered a neighboring apartment through an open door. When officers arrived, the accused grabbed and held onto one of the officers before being detained. No injuries were reported, and no property was taken from the apartment. Following the investigation, the accused, identified as Abnet **TSEGGAI**, was arrested.
