DAILY INCIDENT REPORT

Incidents

Fatal Crash Investigation – On October 15 at 5:45AM, officers responded to the area of James Madison Hwy near Logmill Rd in Haymarket (20169) to investigate a crash. The investigation revealed the driver of a 2012 Freightliner semi-truck, identified as a 53-year-old man, was making a left turn from a private driveway onto James Madison Hwy, attempting to proceed southbound. At the time the truck driver was initiating the turn, traffic was clear in both directions. During the turn, the driver of a Mazda CX5, identified as a 55-year-old man, was traveling northbound approaching the truck. The driver of the truck attempted to make audible and visual signals to warn the oncoming driver by sounding the truck's horn and flashing the headlights. At this time, it appears the driver the Mazda made no attempt to slow or stop their vehicle before colliding with the trailer portion of the truck. The driver of the Mazda died at the scene. The driver of the truck was uninjured. Investigators are continuing to look into factors which may have contributed to the collision. Crash investigators are asking anyone who may have witnessed this crash to contact police.

Arrests

Felony Assault & Battery [Hate Bias] - On October 15, officers concluded an investigation into an assault that was reported to have occurred in the 10700 block of Sudley Manor Dr in Manassas (20109) on September 30 at approx. 11:50AM. The investigation revealed the victim, a 51-year-old woman, had just parked her vehicle in a parking lot of a local business when she was approached by an unknown man, later identified as the accused. During the encounter, a verbal altercation ensued, and the accused reportedly used profanities and derogatory language towards the victim based



on her religion. At one point, the accused began poking at the victim's face leaving notable marks before grabbing her hand. Good Samaritans intervened and the accused left the area. Minor injuries were reported. During the investigation, officers identified the accused and obtained an arrest warrant. Following the investigation, the accused, identified as Matthew Vinod **MALAIKAL**, was arrested.

Assault & Battery on a Law Enforcement Officer [LEO] – On October 16 at 12:49AM, officers responded to the area of Limestone Rd and Linton Hall Rd in Gainesville (20155) to investigate an intoxicated individual. When officers arrived in the area, the individual, later identified as the accused, was determined to be intoxicated. While being detained, the accused resisted and later made threats to officers. Once at the Adult Detention Center, the accused struck an officer with his elbow. No injuries were reported. Following the investigation, the accused, identified as Deon Joshua Seth **WILSON**, was arrested.
