Director Seth Hendler-Voss provided the following updates:

- DCR selected the grant application for Dove's Landing to move forward to the next step in the Land and Water Conservation Fund (LCWF) grant process.
- 1st Tee Tournament was this Monday, It was a great day with 68 participants raising funds for the First Tee program
- DPR will meet with the CXO and Budget team early next month to discuss DPR initiative for FY
   26. These initiatives will be shared with the Commission in November.

- BOCS Directives received by DPR include:
  - Exploring options for community gardens. Staff visited potential sites with the Cooperative Extension and will recommend two sites for the CXO to present the BOCS
  - Masterplan EAST/WEST Recreation Centers staff have developed a scope of work and a consultant will be selected to do a feasibility study. The first report with site recommendations will be ready in the spring.
  - Public Art Task Force A public Art Task Force will be appointed by the CXO to draft a policy recommendation for art installations on public and private property. The Task force will be led by a consultant and include members of the Arts Council, Park Foundation and Park Commission.
  - o Deer Management staff have been asked to present an update on deer management and the status of tick-borne diseases in Prince William County.
  - o Botanical Gardens staff have been asked to explore a botanical garden.
