The CRC's purpose is to help people in crisis in their most difficult and vulnerable moments and guide them toward healing. This will be a 24-hour facility.

<u>Evelyn BruMar</u> – Commissioner BruMar, along with Casa BruMar, will be collaborating with the new Crisis Receiving Center to provide wrap-around services. Vice Chair BruMar was a panelist at the Mental Health Awareness Event held on October 6th at the Ferlazzo building.
