Updates

Murder Investigation *ARRESTS - On November 5, Prince William County detectives, with the assistance of additional local and Federal law enforcement, arrested three men and executed multiple search warrants in connection to the murder of a 21-year-old man during a shooting that occurred in the 15200 block of Potomac Town Pl in Woodbridge (22191) on October 2. The investigation revealed the three suspects targeted or otherwise assisted in the confrontation with the victim at the above location that ultimately led to his death. The shooting also injured an 18-year-old male



acquaintance of the victim who sustained a non-life threatening grazed wound to the lower body during the encounter. Following simultaneous law enforcement operations, one of the suspects, identified as Shawki Saah **FOFANAH**, was apprehended in Surprise, Arizona, while the two other suspects, George Kwasi **ATTAKORA** and Musa Abraham **SESAY**, were arrested locally in Stafford County and Washington DC respectively. Additionally, as part of the ongoing investigation, search warrants were executed at residences located in Dumfries and Stafford County, Washington DC, and the City of Surprise in Arizona. This investigation was aided with the law enforcement assistance from members of the FBI's Phoenix field office, the Peoria Police Department, and the Surprise Police Department in Arizona, the Metropolitan Police Department in Washington DC, the Stafford County Sheriff's Office, and the U.S. Marshals Service.

*Continuation of the investigative update from the previous page.

Homicide Investigation [Previously Released] – On October 2 at 10:48PM, officers responded to Stonebridge at Potomac Town Center located in the 15200 block of Potomac Town Pl in Woodbridge (22191) to investigate a shooting. When officers arrived in the area, two men were located with gunshot injuries. The initial investigation revealed one of the injured parties, identified as a 21-year-old man, had been shot multiple times outside of the Alamo Drafthouse during an encounter with another individual. Officers located the victim on the sidewalk near the location where first aid was provided. Fire & rescue personnel responded to further treat the victim who ultimately succumbed to his injuries. Additionally, an 18-year-old man sustained a non-life threatening grazed wound to the lower body during the encounter. The suspect reportedly left the area immediately after the shooting and was not located. Preliminarily, this incident does not appear random. Detectives are asking anyone with any information, or anyone who may have witnessed the incident, to contact police. Additional information will be released when available. The investigation continues.

Commercial Burglary – On November 6, at 2:29AM, officers responded to the Tobacco Hut located at 4810 Dale Blvd in Woodbridge (22193) to investigate an alarm activation. The investigation revealed a front glass window had been broken out before four masked male suspects were seen entering the business and selecting several pieces of merchandise and a cash register. The suspects were last seen getting into a vehicle and leaving the area. The suspects are believed to be in the late teens.

Solicitation of a Minor | Contributing to the Delinquency of a Minor - On November 4, officers concluded an investigation into inappropriate contact of a minor by an adult that stemmed from an initial encounter that occurred in the Woodbridge (22191) area of Prince William County in September 2025. The investigation revealed on September 9, the victim, who was between 15 and 17 years of age, was walking in the area of Richmond Hwy and River Heritage Blvd when an unknown man, later identified as the accused, stopped his vehicle and offered her a ride. After the initial



encounter, the two parties exchanged phone numbers. Over the course of approximately a month, the accused engaged in inappropriate messages and physical acts on more than one occasion during arranged meetings with the underaged victim. Following the investigation, the accused, identified as Maurice Rashard **CAVERS**, was arrested.

Brandishing of a Firearm - On November 3 at 4:24PM, officers responded to the 14000 block of Worth Ave in Woodbridge (22192) to investigate a road rage incident. The investigation revealed the victim, a 64-year-old man, was driving in the area of the Prince William Pkwy and Shoppers Best Way when he encountered the driver of another vehicle, later identified as the accused. At one point, the parties pulled into a nearby parking lot where a verbal altercation escalated. During the encounter, the accused brandished a firearm before the parties separated. No shots were fired, and



no injuries were reported. Officers were able to obtain a license plate for the other vehicle and responded to their residence where the accused was detained without incident. Following the investigation, the accused, identified as Dwayne **JONES**, was arrested.
