Updates

Armed Robbery *ARREST – On November 13, officers arrested one of the men, identified as Tyree William **HUNTER**, who was sought in connection to the robbery that was reported to have occurred in the 13100 block of Centerpointe Way in Woodbridge (22193) on October 17. The investigation continues as officers seek the second suspect involved in the robbery.

Armed Robbery [Previously Released] – On October 24, officers responded to investigate a robbery that was reported to have occurred in the 13100 block of Centerpointe Way in Woodbridge (22193) on October 17 at approximately 4:20PM. The investigation revealed the victim, a 61-year-old woman, was in the above area when she was approached by two unknown men. During the encounter, one of the men displayed a knife and demanded money from the victim. The suspects took an undisclosed amount of money before leaving the area on foot. No injuries were reported. The victim reported the incident to police several days later.

Filing a False Police Report *ARREST – On November 11, detectives charged the reporting party for filing a false police report in connection to a burglary that was reported to police at an apartment located in the 13100 block of Marina Way in Woodbridge (22191) on October 26. The investigation revealed the accused knowingly reported the burglary to police in which several firearms and other property were allegedly stolen. During the investigation, detectives were able to locate the alleged stolen weapons and additional property at various locations known to the accused, and further determined the burglary never occurred as reported by the accused. Following the investigation, the accused, identified as Kelvin Kedwy **URENA**, was charged.

Residential Burglary [Previously Released] – On October 26, officers responded to investigate a burglary that was reported to have occurred at the Rivergate Apartments located in the 13100 block of Marina Way in Woodbridge (22191) sometime between 3:00AM on October 17 and 8:40PM on October 26. The investigation revealed a resident of one of the apartments returned to their home to discover the front door was unlocked. There were no signs of forced entry into the unit. Multiple firearms, ammunition, an undisclosed amount of money, and other property were reported missing.

Assault & Battery on a Law Enforcement Officer [LEO] – On November 12 at 9:09PM, officers in the 14000 block of Shoppers Best Way in Woodbridge (22193) detained an individual for trespassing behind a business. At one point, the individual, later identified as the accused, struck an officer with his shoulder. No injuries were reported. During a search post arrest, the accused was found in possession of a concealed firearm and suspected illegal narcotics. Brandishing of a Firearm – On November 13, officers concluded an investigation into a brandishing that was reported to have occurred in the 13000 block of Gateway Center Dr in Gainesville (20155) on November 1 at approximately 6:30PM. The investigation revealed the victim, a 19-year-old man, was with other friends when they had an encounter with the driver of another vehicle, later identified as the accused. After a brief verbal exchange, the parties left the location before pulling into a parking lot to the above area. During that encounter, the accused reportedly approached the victim with what appeared to be a firearm in his hooded sweatshirt. The parties eventually dispersed, leaving in different directions. No shots were fired, and no injuries were reported. Following the investigation, officers obtained an arrest warrant for the accused, identified as a Samuel Hanmin **YOO**, who was served on November 13.
