DAILY INCIDENT REPORT

November 20, 2025

Incidents

Fatal Crash Investigation – On November 19 at 6:18AM, officers responded to the area of Old Centreville Rd & Parkland St in Manassas (20111) to investigate a crash. The investigation revealed the driver of a 2004 Honda Accord was traveling northbound on Old Centreville Rd at a high rate of speed, attempting to pass other vehicles. At one point, the vehicle entered a turn in the above area in the opposite lane of travel and struck a 2021 Ford F150 that was traveling southbound on Old Centreville Rd. The driver of the Honda, identified as a 34-year-old man, was pronounced dead at the scene along with a Yorkie that was located inside the vehicle. The driver of the Ford, a 65-year-old man, was transported to an area hospital with serious injuries. **Crash investigators are asking anyone who may have witnessed this crash to contact police.**

Death Investigation – On November 18, officers began an investigation into a death that reportedly occurred at the PS Business Park located at 3091 PS Business Center Dr in Woodbridge (22192) on or around November 3. The investigation revealed on November 3, a private tow company contracted to conduct tow services at the business park had towed a vehicle from the parking lot which eventually was transferred to another tow lot location in Fairfax County. On November 18, employees at the Fairfax County tow lot contacted Fairfax County police after a body was located inside the vehicle in the back seat floorboard area. The deceased is believed to be the vehicle owner, preliminarily identified as a 49-year-old man, who had been reported missing in Prince William County on November 1. At the time of the missing person report, no foul play was suspected in the disappearance, and the individual was not considered endangered. Prince William County police detectives responded to conduct the death investigation. The body was transported to the medical examiner's office to confirm the identity and determine cause and manner of death. Preliminarily, there were no signs of foul play or threat to the community concerning the death. More information regarding the investigation will be released if deemed necessary.

Indecent Exposure – On November 19 at 7:12PM, officers responded to the Wegmans located at 14801 Dining Way in Woodbridge (22191) to investigate an indecent exposure. The investigation revealed the victim, a 27-year-old woman, was inside the store when she observed an unknown man expose himself before leaving the store on foot. No physical contact occurred between the two parties. The suspect was described as a black male, 30s, approximately 5'5" with facial hair.
