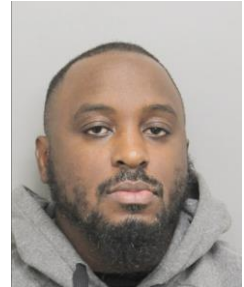
Indecent Exposure *ARREST – On November 21, the suspect, identified as Vincent Leon **CHERRY**, who was sought in connection to an indecent exposure that was reported to have occurred at the Wegmans located at 14801 Dining Way in Woodbridge (22191) on November 19, was arrested.

Indecent Exposure [Previously Released] – On November 19 at 7:12PM, officers responded to the Wegmans located at 14801 Dining Way in Woodbridge (22191) to investigate an indecent exposure. The investigation revealed the victim, a 27-year-old woman, was inside the store when she observed an unknown man expose himself before leaving the store on foot. No physical contact occurred between the two parties. The suspect was described as a black male, 30s, approximately 5'5" with facial hair.

Incidents

Death Investigation – On November 23 at 12:31AM, officers responded to the Prince William County Landfill Complex located at 14811 Dumfries Rd in Manassas (20112) to investigate a death. The investigation revealed contact was unable to be made with a security guard at the complex. Officers arrived at the location and found the guard, identified as a 75-year-old man, unconscious and unresponsive in a water basin on the property. The man was pronounced dead on scene. Preliminarily, there were no signs of foul play concerning the death. More information regarding the investigation will be released if deemed necessary.

Aggravated Assault – On November 21 at 2:13PM, officers responded to Round 1 Bowling and Amusement located in Potomac Mills at 2700 Potomac Mills Cir in Woodbridge (22192) to investigate an assault. The investigation revealed the victim, a 19-year-old man, was playing a game inside the business when he was approached from behind by an unknown man. During the encounter, the man put the victim in a choke hold before releasing him and walking away. No injuries were reported. The suspect left the business prior to officers arriving on the scene and was not located.

Suspect Description:

A black male, 30-40 years of age, with a thin build and full beard

Last seen wearing a red winter hat, red long-sleeve shirt with the “Grinch” depicted on the front, red sweatpants, and white shoes

Armed Robbery – On November 23 at 10:23PM, officers responded to the 14500 block of Watson Ln in Woodbridge (22193) to investigate a robbery. The investigation revealed the victim, a 19-year-old man, was approached by two unknown men while riding an electric scooter in the above area. During the encounter, the men reportedly brandished firearms and took the victim’s phone before leaving the area on foot. No injuries were reported. A police K-9 searched the area for the suspects who were not located. The suspects were described as black males, possibly in their late teens, wearing all dark-colored clothing and masks.

Reckless Handling of a Firearm – On November 22 at 1:37PM, officers responded to the area of Acadia Dr and Pacific Rim Ter in Dumfries (22025) to investigate a shots fired call. The investigation revealed multiple callers reported hearing several gunshots in the area. As officers were responding to the scene, another call was received regarding a crash that occurred in the 17400 block of Bayou Bend Cir where four younger-ages black males were seen running from the crashed vehicle into the nearby woods. A police K-9 searched the area for the occupants who were not located. Two homes in the area were struck, no injuries were reported. Multiple shell cases were also located. Both incidents were believed to be related. The suspects were only described as wearing all dark-colored clothing.

Reckless Handling of a Firearm – On November 23 at 3:21PM, officers responded to a residence located in the 3700 block of Graham Park Rd in Triangle (22172) to investigate a destruction of property. The investigation revealed the homeowner found a bullet that had struck the roof area of the home. No injuries or other property damage were reported. It is unknown when the round struck the residence.

Vandalism on School Grounds – On November 18, the School Resource Officer (SRO) assigned to Bull Run Middle School located at 6308 Catharpin Rd in Gainesville (20155) was notified of vandalism to the ball field that reportedly occurred on October 31. The investigation revealed racial slurs, and inappropriate language had been spray painted on multiple items on the property. No additional markings were reported, and the markings were subsequently removed. School staff were able to identify two 12-year-old students as being involved in the incident. No criminal charges were pursued.

Arrests

Allowing Access to Firearms by Children – On November 22 at 1:49PM, officers responded to the Townsquare at Dumfries Apartments located in the 3900 block of Townsquare Ct in Dumfries (22026) to investigate a shooting. The investigation revealed the victim, a 4-year-old boy, was able to access an unsecured firearm that was inside a closet. As the child handled the weapon, it discharged, striking the victim in the leg. Arriving officers rendered immediate aid to the victim who was treated at an area hospital where the injury was determined to be non-life threatening. Following the investigation, the child's father, identified as Gerardo Anthonio **MEJIA**, was charged.

Brandishing of a Firearm – On November 22 at 5:02PM, officers responded to the 7400 block of Somerset Crossing Dr in Gainesville (20155) to investigate a brandishing. The investigation revealed the victims, a 33-year-old man and a 29-year-old woman, were walking to their vehicle in a parking lot in the above area when they encountered the driver of a vehicle, later identified as the accused, who reportedly almost struck them. As the parties separated, the same man brandished a firearm towards the victims as they were exiting the parking lot. No shots were fired, and no injuries were reported. Officers arrived and detained the accused without incident. Officers determined the accused had discarded the firearm in the bathroom of a nearby business where the weapon was subsequently recovered. Following the investigation, the accused, identified as Dawaine Anthony **LOVITT**, was arrested.

Assault & Battery on a Law Enforcement Officer [LEO] – On November 22 at 4:34PM, officers at Potomac Mills located at 2700 Potomac Mills Cir in Woodbridge (22192) attempted to speak to juvenile who had been recently reported missing. During the encounter, the juvenile refused to comply with the officers and attempted to flee on foot. A struggle ensued, and the juvenile struck an officer before being detained. No injuries were reported. Following the investigation, the accused, identified as a 15-year-old male juvenile, was arrested.

Indecent Exposure – On November 21, officers concluded an investigation into an indecent exposure that was reported to have occurred at Conway Robinson Park located at 12816 Lee Hwy in Gainesville (20155) on November 1 at approximately 2:50PM. The investigation revealed the victim, a 66-year-old woman, was hiking in the park when she encountered an unknown man, later identified as the accused. After a brief interaction, the parties separated. A short time later, the victim observed the accused standing in a wooded area exposing himself and contacted police. On November 8, following the investigation, officers obtained an arrest warrant for the accused, identified as Khalil Rashaud Jabari **CHRISTOPHER**, who was later served on November 21.
