CITIZEN'S TIME

Ms. Pat Victorson commended all staff for their excellent work on the Crisis Receiving Center Complex Ribbon Cutting Event. She shared information on NAMI's new program, currently being piloted, called Creative Mindsets. Additionally, she shared that NAMI PW completed the first "Compartiendo Esperanza" group with Spanish speaking ladies and received positive feedback. NAMI is working with the health department in the route one corridor to dive deep into the Spanish speaking population's needs and concerns.

Virginia Heuple introduced Alyssa Larsen, one of the Early Intervention Program Managers.

Elise Madison highlighted the great job that Princess, The PR Committee, Emergency Services and connections did with the Worth Avenue Crisis Receiving Center Complex Ribbon Cutting. Additionally, Elise shared that Connections has received their adult license for the adult 23 hr. recliners as well as the adult beds, they are just waiting on some finishing touches for them to open.

PRESENTATION: New Horizon's Grant Update- Heather Martinsen & LaChondra Everett

LaChondra Everett provided an overview of the New Horizons Program, highlighting recent changes, growth, service trends, and grant updates. She reported that New Horizons' Treatment and Recovery and Community-Based programs achieved a 92.4% customer satisfaction score in FY25. The program provided outpatient therapy to 420 youth and their families and delivered

school-based services to 723 high school students across 16 high schools in greater Prince William County. Probation services were provided to 245 youth and their families. In the second year of the SAMHSA System of Care grant, 172 new youth were assessed and served using Evidence-Based Practices.

Heather Martinsen provided an overview of the Wellness and Prevention Program, highlighting initiatives such as Lock & Talk, Gambling and Problem Gambling Prevention, and the Fentanyl Exposed campaign. She reported on extensive community outreach, including trainings offered in English and Spanish and partnerships with local agencies, businesses, and community groups to promote education and awareness. The team distributed 2,033 boxes of naloxone (4,068 doses) an increase from previous years, the team distributed 1,205 Lock & Talk safety devices, and participated in 78 community events.
