Updates

Shooting into an Occupied Dwelling *ARREST – On December 16, detectives arrested a suspect sought in connection to the shooting that was reported to have occurred in the 1800 block of Cedar Cove Way in Woodbridge (22191) on November 28. The investigation revealed the suspect targeted a 25-year-old woman who was at a residence in the above area. The accused and the victim had been in an ongoing dispute, and the accused had sent the victim threatening messages leading up to the shooting. Following the investigation, detectives obtained multiple arrest warrants for the accused, identified as D'Avion Ervin **SMITH**, who was arrested on December 16 at his home in Woodbridge.



Arrested on December 16:

D'Avion Ervin **SMITH**, 26, of Woodbridge

Charged with 1 count of *discharging a firearm at a dwelling*, 1 count of *possession of a firearm by a convicted felon*, 1 count of *discharging a firearm in a public place*, 1 count of *stalking*, 2 counts of *felony destruction of property*, and 1 count of *making threats in writing*

Court Date: **Pending** | Bond: **Unavailable**

Reckless Handling of a Firearm [Previously Released] – On November 28 at 10:51PM, officers responded to the Commons on Williams Square Condominiums located in the 1800 block of Cedar Cove Way in Woodbridge (22191) to investigate a shots fired call. The investigation revealed a single gunshot struck a residence. No injuries or other property damage were reported. **This incident does not appear to be random.**

Felony Destruction of Property *ARREST – On December 16, officers arrested a suspect sought in connection to the vandalism that was reported to have occurred at Andrew Leitch Park located at 5301 Dale Blvd in Woodbridge (22193) on December 7. During the investigation, officers learned the estimated damage to the property was approximately \$5,400. On December 16, officers obtained detention orders against the accused, identified as a **17-year-old male juvenile**. Based on the nature of the markings, a hate bias enhancement was sought for the offense.

Vandalism [Previously Released] – On December 7 at 11:03AM, officers responded to Andrew Leitch Park located at 5301 Dale Blvd in Woodbridge (22193) to investigate a vandalism. The investigation revealed several locations within the park where spray painted with markings that included homophobic and antisemitic remarks, as well as other derogatory language and images. The incident is believed to have occurred sometime December 3 and December 7. No suspect(s) information was provided.

Incidents

Death Investigation – On December 15 at 1:36PM, officers responded to a residence located in the 7900 block of Flager Cir in Manassas (20109) to assist the Department of Fire & Rescue with a house fire. During the incident, two residents of the home, a 92-year-old woman and a 74-year-old woman, were transported to an area hospital where they both later died on December 16. Preliminarily, there were no signs of foul play. The cause and manner of the deaths are pending with the Medical Examiner's Office. The cause of the fire remains under investigation by the Fire Marshal's Office. More information regarding the investigation will be released if deemed necessary.

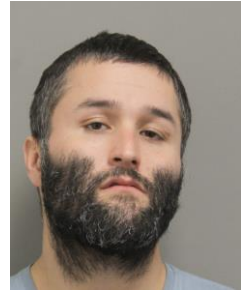

Arrests

Strong-Arm Robbery – On December 16 at 12:28PM, officers responded to the area of Richmond Hwy and Opitz Blvd in Woodbridge (22191) to investigate a robbery. The investigation revealed the victim, a 70-year-old man, was walking in the above area when he was approached by an unknown man, later identified as the accused. During the encounter, the accused struck the victim, knocking him to the ground where the assault continued. While on the ground, the accused took a bag from around the victim's waist and walked away. Minor injuries were reported. Officers circulating the area located the accused who matched the description provided by the victim. Following the investigation, the accused, identified as Alexander Michael **SEALS**, was arrested.
