**Old Business**

- Universal Human Rights Day will be held on January 17, 2026, at 10 AM at the James J. McCoart Building – Board Chambers. This year's theme is "From Reconstruction to the Future: 250 Years of Civil Rights Progress" with a focus on the 14<sup>th</sup> Amendment.
- The guest speaker will be Dr. James "Jay" Gillispie, Dean at Northern Virginia Community College (NOVA).
- The program will begin at 10 AM, and we are asking all commissioners to arrive by 9:30 AM.

### **Committee Reports**

#### **Jail Board**

- Director Torres was on vacation during the November Jail Board meeting and has no updates to report.
- The next Jail Board meeting will be held on January 21, 2026.

#### **Student Leadership Council**

- Prince William County Public Schools hosted their session on December 10, 2025. The focus was on Education and Prevention to promote an Inclusive Environment Among Students. 48 students were in attendance.
- The next session will be held on January 15<sup>th</sup> at the Kelly Leadership Center, from 4:30PM – 6:30PM. This session will focus on Fair Housing. Mahalia “Mally” Dryden-Mason will be the Presenter.
- A select group of students will participate in Universal Human Rights Day on January 17<sup>th</sup>. On January 19<sup>th</sup>, they will also take part in the 41<sup>st</sup> Annual Dr. Martin Luther King, Jr. (MLK) Youth Oratorical Competition and Program.

#### **Director's Report**

- The office has a total of 38 Charges that are open and actively being investigated.
- The HRO is awaiting direction from Human Resources regarding veteran preferences. Now that the new DCXO has been hired, she will meet with the HR Director and the Legal Department to discuss the County's next steps on this matter.
- On December 16<sup>th</sup>, the office will be hosting a webinar that will focus on Veteran discrimination. The speakers will be;

On December 13th, Commissioner BruMar will be collecting her keys to the new Casa BruMar Community Center, which will be located at the Woodbridge Business Center. The center will occupy an entire floor, with half dedicated to Community Services and the other half forming a partnership with Prince William Health Centers. It will serve Pride clients with wrap-around services and include a pharmacy. There will be a soft opening on Valentine's Day, followed by a grand opening during the summer.

Chair Porter - Chair Porter would like to arrange a meeting with Supervisor Stewart to introduce the Human Rights Commission and discuss our mission and activities.
