### Incidents

**Fatal Crash Investigation** – On January 11 at 6:52PM, officers responded to the area of Kettle Run Rd & Schaeffer Ln in Nokesville (20181) to investigate a crash. The investigation revealed the operator of a 2023 Harley-Davidson Road Glide, identified as a 52-year-old man, was traveling southbound on Kettle Run Rd, approaching Schaeffer Ln. The operator attempted to navigate a left curve, and ran off the roadway to the right, striking the concrete culvert of a driveway in the 10700 block of Kettle Run Rd. The operator of the Harley-Davidson was transported to an area hospital where he later died. **Crash investigators are asking anyone who may have witnessed this crash to contact police.**

**Death Investigation** – On January 11 at 10:26PM, officers responded to an area near the 8200 block of Sudley Rd in Manassas (20109) to investigate a death. The investigation revealed the deceased, identified as a 58-year-old man, was located in a wooded area near the above location. The man was pronounced dead on scene. Preliminarily, there were no signs of foul play concerning the death. More information regarding the investigation will be released if deemed necessary.

**Reckless Handling of a Firearm** – On January 12 at 4:36AM, officers responded to the area of Oak St and Spicewood Ct in Manassas (20111) to investigate a shots fired call. The investigation revealed multiple gunshots were heard in the above area. No injuries or property damage were reported. Several shell casings were located in the 7800 block of Oak St. No suspect information could be provided.

**Reckless Handling of a Firearm** – On January 9 at 10:45PM, officers responded to the area of Old Kings Rd and Blacksmith Tr in Woodbridge (22191) to investigate a shots fired call. The investigation revealed multiple gunshots were heard in the above area. No injuries or property damage were reported. The location of where the gunshots were fired could not be determined. No suspect information could be provided.



## Arrests

**Reckless Handling of a Firearm** – On January 11 at 11:47PM, officers responded to the 7500 block of Old Linton Hall Rd in Gainesville (20155) to investigate a reckless handling. The investigation revealed the accused was involved in a verbal altercation with another individual that escalated physically. During the encounter, the accused fired a handgun into the air before leaving in a vehicle. No injuries or property damage were reported. Officers located and stopped the vehicle nearby where the accused was detained without incident and found to be intoxicated. Following the investigation, the accused, identified as Christian Jorel **BROWN**, was arrested.

**Reckless Handling of a Firearm** – On January 10 at 12:48PM, officers responded to a residence located in the 4100 block of Mount Atlas Ln in Haymarket (20169) to investigate a reckless handling. The investigation revealed the accused was involved in a verbal altercation with a family member. At one point, the parties separated and the accused retrieved a firearm, firing the weapon once inside the home into a mattress then in the air outside of the residence. No injuries or other property damage were reported. Officers detained the accused without incident where he was found to be intoxicated. Following the investigation, the accused, identified as Dennis **PARK**, was arrested.
